## 2024/26/04 Divet Hill Liaison Committee

Liaison Committee meeting to be held next week. Blasting measurements indicate they are well within the permitted guidelines. As the quarry progresses and opens up, the blast consequences will lessen. A lot of effort is being put into minimising the effects of blasting. Due to resident concerns, the age of some buildings built in the 1600s would be brought up, with respect to the effect of blasting.

#### 2024/27 To consider issues with path to Church

Concern expressed over access to church, due to slippiness of path during certain times of the year. Proposal to make a track within the wall, but this would not address slippiness opposite the Manse. Substantial expense would be involved, church numbers were declining, and to make the path accessible there would need to be lighting. Pre-planning application had been submitted to County Council.
