2022/63/01 To consider improvements to Thropton play area and financial implications

County Council had advised the rubbish bin at the play area could not be opened correctly. As there was a bin in storage it was resolved this would be used to replace the damaged bin.

2022/63/02 To consider most recent play area inspection reports, including annual ROSPA report

Annual ROSPA play area inspection report had referred to overhanging tree branches; monitoring and greasing of rotator bearings; uneven swing surface, and consideration to be given to re-seeding of ground. Clerk had forwarded copy of report to A Kidd and would make contact to consider points that need actioned.
