2022/17 Apologies for absence

There were no apologies for absence.

2022/18 Declaration of Members Interests

There were no Declaration of Members Interests.

2022/19 Co-Option Vacancy

There were no applications for the co-option vacancy.

2022/20 Public Questions

J Car, member of Thropton Together and new Chair of the Village Hall present. The Committee were planning to register the hall as an emergency centre in times of crises. Community Group Thropton Together had set up community support, with 25 volunteers secured and the village divided up to carry out checks on parishioners in times of crises. Rothbury Parish Council had set up a Crises Management Working Group with community partners. J Carr willing to become part of the group, and it was agreed this would be beneficial for the parish.

2022/21 Minutes of previous meeting held Tuesday 18th January 2022

It was resolved that the minutes of the previous meeting held Tuesday 18th January 2022 be accepted as a true record.

2022/22 Thropton Play Area

2022/22/01 To consider improvements to Thropton play area and financial implications

Children had been spoken to about relocating the goalpost, however they play football both ways and the ball would still go through the fence. There had been goalpost nets in the past, however they are easily damaged and cause safety issues.

2022/22/02 To receive progress with tree planting in the parish

Three trees planted within the play area had already been knocked over. Gardener had advised cutting would take longer and lead to higher costs, and they should have been planted outside of the play area. Neighbouring residents had been spoken, along with a tree expert, who agreed with the location, however the trees nearest to the goalpost would be reassessed. There were 40 trees in total to be planted, and 80 surplus, which would be available to parishioners and be advertised via Thropton Together Facebook page.

Netting had previously been agreed to block the fence off and prevent balls entering the field. It was therefore resolved to request a quotation from A Kidd to place netting.
