2023/05 Thropton Play Area

2023/05/01 To consider most recent play area inspection reports

The report indicated that there was some minimal damage to the new goalpost netting and mole hills were appearing on grass surfaces. The rocker dog equipment had been removed, with the base remaining and which would be monitored at the monthly inspections. There were still outstanding equipment repairs, however the current contractor had tonight informed the Clerk he was no longer able to carry the repairs out or future grasscutting, but could continue with the monthly play area inspection. It was resolved to seek quotes for fortnightly grasscutting April to September annually, for consideration at the next Parish Council meeting, with Cllr Tuckey to carry out repair to rocker dog equipment.
