C Hughes declared an interest in **2023/124/02** - Middleton & Todridge Village Hall – rent of meeting room 25/9/23 - £20.00. M Seth declared an interest in **2023/131 To consider grit bins – existing and provision of additional bins in the parish.**

2023/113 Co-Option Vacancy

One application had been received for the vacancy, and it was resolved to co-opt S Pattison.

2023/114 Opportunity for members of the public to raise any matter

There were no matters raised by members of the public.

2023/115 Minutes of the previous meeting held on Monday 25th September 2023

It was resolved that the minutes of the previous meeting held on Monday 25th September 2023 be accepted as a true record.

The agenda item relating to audit of rural footpaths (which D Thompson is carrying out), is not the same item as outstanding works required to footpaths – audit of footpaths to be attended to next agenda.

2023/116 To consider future aims and objectives of the Parish Council

E Green concerned about Middleton footpath – County Council had advised via Fix My Street that the area would be actioned. S Pattison had reported drainage/flooding issues to County Council on several occasions. Cllrs to bring aims and objectives to the next Parish Council meeting, and which should be community objectives. C Hughes advised he already receives parishioner feedback. D Dexter stated aims and objectives should be separated, and suggested the Parish Council produce a statement of their aims and objectives. D Thompson interested in broadband matters.

2023/116/01 To consider regular parish tidy up event(s)

Residents had carried out leaf clearance in Scots Gap. S Pattison had historically been involved with tidy up events in Cambo, and event would be arranged in due course.

2023/117 To consider quotations for Parish Council noticeboard and street furniture items and approve funding application to County Cllr

C Hughes advised the funding available wouldn't work, there is no suitable site, and suggested the existing noticeboard be removed, and project dropped. M Seth to look into agendas being placed in the chapel noticeboard. L Brown to place agenda in noticeboard at Scots Gap.

2023/118 Speeding traffic within the parish/request to lower speed limit at Middleton

County Council Officer had implied Middleton was not large enough to lower the speed limit. D Thompson had drafted a petition to lower the limit, and which would require 50 signatures in order for the County Council to consider. It was resolved petition would be organised - D Thompson to action.

2023/119 To consider Parish Council fund interactive speeding signage at Scots Gap

County Council had provided four quotations, reported at the previous meeting. Clerk advised as the County Council could not provide proof of problems with speeding vehicles – further to two speeding surveys arranged in the parish - grant funding would be difficult to secure. M Seth to make enquiries via the Ray Wind Farm grant fund.

2023/120 To consider drainage issues within the parish

Northumbrian Water had visited Middleton, however this would likely be due to a burst pipe. Flooding issues continue. Problems had been re-reported via Fix My Street. Drains at Middle Row Cambo problematic, which is the responsibility of National Trust. Item to be removed from agenda.

County Cllr had forwarded an update. The parish to be moved to Bellingham ward from May 2025, despite the Parish Council submitting an objection.

2023/123 National Trust Update

C Hughes advised signage for the Wannie Line would be erected this week, together with new boards explaining the Newbiggin Farm proposals. Cambo noticeboard is National Trust property and they would not be replacing it, however the Parish Council could discuss with the Trust about placing their own funded noticeboard in Cambo. There were no plans for the old Trust headquarter building. Trust aware of proposal for new Clubhouse at Wallington F.C, with meeting required between Trust and Council.

2023/130 To consider proposal for new clubhouse at Wallington F.C.

Clubhouse had been condemned. Grant funding had been received from Ray Wind Farm to produce proposal, which was essentially a larger version of existing. New F.A. regulations included the requirement for larger male and female changing rooms and a disabled W/C. There was a requirement in the league for catering after matches, and this could be organised at the new clubhouse. Cambo Young Farmers occasionally use the clubhouse, and which could also be a

possible location for Parish Council meetings. Club had been in contact with the National Trust. Planning application to be submitted shortly. The design is the cheapest possible. The Parish Council were the leaseholder, C Hughes to liaise with National Trust.

2023/131 To consider grit bins – existing and provision of additional bins in the parish

There are no footpaths at Willow Park, and County Council grit wagon does not grit the estate. It was resolved the Parish Council would fund and pay to refill a bin, which should be located 5m from the footpath outside No 1. Clerk to submit request to County Council.
