Minutes of Meeting held in the Parish Hall on Friday 5th October 2018 at 7.30pm

A warm welcome was extended to Trevor Elliott, the newly co-opted councillor. Trevor duly completed Acceptance of Office and Register of Interest forms.

2.5/10 Minutes: - The minutes of the last meeting which had been distributed were agreed, and signed by chairman, Royston Symons

3.5/10 Matters arising

Bus shelter at Grimscott - In order to apply for grant aid, it is necessary to confirm in writing, whether planning permission is required. A fee of £50 is payable which was unanimously agreed.

Neighbourhood Planning - Cornwall Council postponed the training session due to be held in September, due to sickness. Copies of a report on the future of Neighbourhood Plans which has been commissioned by NALC, were discussed and the matter was carried forward to the next meeting in order to give everyone a chance to read and fully understand the situation.

Grimscott Estate - Cornwall Housing have promised to write to all residents of Grimscott Estate asking them to refrain from parking on the grass on the central island.

Permitted Development rights - A reply received from the Planning Enforcement Officer, indicated that the matter had already been reported by A.N. Other, investigated and concluded that “no breach of planning control had taken place”. This was deferred for further action / comments until the complainant contacted.

Bonfire Night - A” Soup & Sweet” event will be held in the Hall on Saturday 20th October, in order to raise funds towards fireworks display on 3rd November.

4.5/10 Playing Field - New signage and key safe for safety checks are now in place, an additional ‘No dogs’ sign will be placed at the entrance by the Parish Council. Trevor Elliott agreed to forward details of a sign in neighbouring parish as a suggestion for suitable wording. Alan Whittle gave details of a website to consider giving the Parish Council powers to issue fixed penalty notices for dog owners who continue to exercise dogs in the field.
