# LAUNCELLS PARISH COUNCIL

Minutes of meeting held in the Parish Hall on Friday 5<sup>th</sup> December 2014 at 7.30pm

<u>PRESENT</u>: Andrew Hargreaves, Margaret Cleave, Peter Harwood, Sheridon Rosser, Brian Pollard, Graham Tape, Royston Symons, Maxwell Allin <u>APOLOGIES FOR ABSENCE</u>: Christine Hobbs, Paul Wingard, Paula Dolphin <u>MINUTES</u>: The minutes of the last meeting were approved and signed by the chairman.

<u>PLAYING FIELD:</u> Nothing further has been heard about grant funding or extra play equipment since the last meeting.

It was proposed by Graham Tape, seconded by Margaret Cleave and unanimously agreed to accept quotation from Tom Rosser of £400 for cutting the western boundary hedge and clearing ditches. Sheridon Rosser declared an interest and took no part in this matter.

Maxwell Allin agreed to trim the hedge on the southern side when weather permits.

<u>PARISH HALL:</u> Mr Pengelly declined to quote for removal of boundary hedge, a request to be put in the parish magazine and online, for volunteers to do the work in exchange for free logs.

The Hall Management Committee agreed to last month's request of granting £400 towards external decoration of the Hall. It was suggested that it may be better at this stage to replace soffits rather than clean and replace existing, so a further quote to be obtained before grant application is completed. Drawings have been received for proposed archive storage room at the Parish Hall. At this stage Proposal No 1 is the preferred option and Royston Symons agreed to inform Mr Pearson and to correspond with him on matters voiced by councillors.

councillors on site before submission of any comments to Planning Dept. Margaret Cleave as a neighbour declared an interest and declined to take part. **FINANCE:**

It was decided to defer awarding of grant aid to local organisations until the January meeting.

Andrew Hargreaves reported on recent meeting held at Camelford regarding "Cornwall for change", with issues / complaints about unsatisfactory performance of council officers, not elected councillors. Cornwall for change wish to set up a steering group for North Cornwall and asked Andrew Hargreaves to be a representative on agreement of the Parish Council, which was duly given. A list of complaints to be drawn up including Land Drainage Officer, Conservation officer regarding wind turbine issues and Planning Enforcement Officer.

### **OTHER MATTERS:**

Having drawn up a list of past chairmen of the council, the clerk will in due course arrange for suitable plaques to be made, for placing on the new Playing Field seat.

The chairman to contact Cornwall Council Democratic Services regarding issues with alleged contravention of planning regulations and what evidence can be obtained without infringing on any individuals privacy.

Thanks were expressed to all who helped make bonfire night a great success with particular thanks to those who helped make the bonfire.

The state of road which leads to Launcells Church has been reported to Highways.
