Matters arising:

Defibrillators - Rob White of ESP Training & Consultancy to be invited to give a short Defib only course in the Parish Hall on Friday 10th March.

A grant application has been made to the Local Devolution Fund for funding towards purchase of a Defibrillator.

Paths - Approval had been given for path on Common land to include creating of an access bridge. The work was recently completed by Royston Symons & Tom Rosser. It was agreed to purchase a dog bin with assistance of funding from Paula Dolphin's Community Chest and to place this on The Commons until a possible area is created around the Playing Field.
