- 1176. PRESENT: Cllr M D Senior, Chairman of the Council together with C Roe, C Turnbull, S Lynch. In attendance: Mrs M Senior, Clerk to the Council
- 1177. APOLOGIES FOR ABSENCE Cllr S Glover and Cllr R D Lillie
- 1178. DECLARATIONS OF INTEREST. None
- 1179. RESIDENTS.
 - a) TREES/PLANTERS. Hazel Holliday has taken over looking after the planters at the west end of the village. Thanks to Hazel for doing this on behalf of the village. The gardening club is going to plant some more trees along the verge at the west end of the village.
 - b) PLAY AREA. The reasons for the locking of the maintenance gate to the play area was questioned again. This is due to health and safety reasons and will remain locked. NCC will only relocate the play area sign if the Parish Council pay for them to do it. It was AGREED to arrange this.
 - c) FOOTPATH REPORT. Maurice Holliday gave an update on the state of the footpaths around the parish. Maurice had carried out work on several footpaths and stiles, cutting back hedges and undergrowth. The finger post at Horsley Banks Farm is hidden in the undergrowth. It was noted that the gate at the top of Lead Lane is still to be replaced. The seat at the west end of the village needs repaired and this and the other seats are covered in lichen. The clerk will arrange for the seat to be repaired and the all seats to be cleaned and treated.
 - **d) GULLEYS.** Most of the gulleys along the main road in the village are blocked. These have been reported however this will be chased up.
 - e) **ENABLING COMMUNITIES.** Jude Deeks, Locality Co-ordinator from the Enpowering Communities Project has arranged a meeting on Saturday 21 September at 2.30pmin The Hearth to see if they can assist Horsley in anyway with community projects.
 - f) BUS SHELTER. A planter and climber have been placed beside the bus shelter at Cherry Tree Gardens to hopefully assist in keeping the rain off people waiting for the bus.
 - g) KISSING GATE. The kissing gate at the bottom of Croft Lane is in need of repair. NWL will be contacted to see if they will repair/replace.
- 1180. MINUTES. It was proposed by Clir M D Senior, seconded by Clir C Turnbull and AGREED that the minutes of the meeting held on 3 July 2019 be signed as an accurate record.

 1181. MATTERS ARISING
 - a) TRAFFIC/PARKING. Minute 1165e refers. It was noted that the Community Speed Watch volunteers had been out monitoring the traffic recently. This information is passed to the police. Cllr M D Senior is to arrange a site visit with NCC officers from the Highways Dept to see what options would be available in Horsley to improve the speeding/parking problems.
 - **b) HORSLEY WOODS FOOTPATH.** The landowner had been contacted to request a permissive path through the woods.
- 1182. COUNTY COUNCILLOR REPORT. County Councillor Karen Quinn gave a verbal update on matters relating to NCC and Horsley area. The sign at the west end of the village had been reported and NCC advised that they are to clear the gulleys from Horsley to Close House. The Village Hall windows, and heating had been replaced with funds from Karen's members funding. Thanks were expressed to Karen for her help with this. No update had been received on the planning applications relating to Horsley Banks Farm and one of the applications had been removed from the planning portal. 1193. VILLAGE ISSUES

- a) VILLAGE TIDY UP. Thanks were expressed to Craig Turnbull for cutting back the hedge from the seat in the play area and planting up the small planter; Daniel Senior for painting and clearing out the bus stops; David Goldwater for tidying up the footpath by the Business Park and Maurice Holliday for cutting back the undergrowth around the various footpaths and stiles.
- b) GRASS CUTTING CONTRACT 2020-2023. The schedule of works for the grass cutting has been updated to include cutting of the hedges in the play areas, weed spraying and tidying up the verges. The notice will be displayed from mid-October with tenders to be received by 15 November.
- **1193. LOCAL TRANSPORT PLAN PROGRAMME 2020-2021.** NCC is asking Parish Councils to submit their top three highways and transport priority issues so they can be considered for inclusion in the LTP Programme for 2020/21. It was agreed to put forward the following priorities:
 - a) Resurfacing of Mill Way
 - b) Resurfacing west end of the village between WI and rumble strips
 - c) Improvements to pavements on north side of the road.

Feedback had been received on the priorities put forward for the 2019/20 LTP. The results are below:

- a) OVINGHAM JOINT BURIAL COMMITTEE. The burial fees for the cemetery are being reviewed with fees being separated for residents and non-residents. NCC is to carry out topple testing on the headstones in the cemetery. The groundworks contract is coming up for tender.
- b) EAST TYNEDALE PARISH AND TOWN COUNCILS FORUM. A letter box with a larger opening was requested for Horsley by tenants of the Business Park. This will be looked into.
