MINUTES OF THE MEETING OF THE PARISH COUNCIL HELD ON MONDAY 18 JULY 2016 AT 7.00PM IN THE WI/VILLAGE HALL (Subject to Parish Council approval)

- **0814. PRESENT:** Cllr M D Senior, Chairman of the Council together with Cllrs A Turnbull, P Taylor, S Lynch, C Rodgers
 - In attendance: Mrs M Senior, Clerk to the Council
- 0815. APOLOGIES FOR ABSENCE. Cllr D Lillie
- **0816. DECLARATIONS OF INTEREST.** Cllr A Turnbull declared a personal interest in matters relating to Northumbria Water.
- 0817. RESIDENTS.
 - a) TELEPHONE BOX. It was noted that BT are still to remove the phone box.
 - **b) WAR MEMORIAL**. A full planning application is to be submitted for the repairs to the war memorial based on the recommendations from the pre planning application advise. Mandy Senior is to meet with Nick Rowsell to go over the details of the full application.
 - c) BOTTLE BANK. A small bottle bank was requested and several locations suggested. Cllr S Lynch is to approach the business park to see if one could be located in their car park.
 - **d) SIGNS.** The large sign to the west of the village had been removed by NCC as it was dangerous. A new sign had been ordered and will be replaced in due course. It was noted that although the post appear to be rusty they are in sound condition.
 - e) TRAFFIC CALMING MEASURES. Unfortunately, the rumble strips could not be located in the centre of the village due to the noise for neighbouring houses. It was also noted that warning signs should be installed to advise motorists. It was suggested that the 30mph be moved closer to the Vehicle Activated Signs and the sign be changed to indicate actual speed instead of 30mph warning.
- **0818. MINUTES.** It was proposed by Cllr P Taylor, seconded by Cllr M D Senior AGREED that the minutes of the meeting held on **18 July 2016** be signed as an accurate record.
- 0819. MATTERS ARISING.
 - a) COMMUNITY SPEEDWATCH. Minute 811d. Cllr P Taylor had attended a meeting regarding Community Speedwatch. There are currently 15 volunteers in Tynedale and 2 cameras. If more volunteers are recruited then additional camera can be obtained. To apply to be Community Speedwatch volunteer residents need to apply online at Northumbria Police by 23 September.
- **0820. CORRESPONDENCE.** All correspondence and information items received since the July meeting had been listed on the agenda and most of this correspondence had been circulated by email.
- **O821. UNAUTHORISED OBSTRUCTIONS IN THE HIGHWAY.** NCC had been approached by RNIB and the Northumberland Low Vision Action Group who both raised concerns about street clutter and the effect it is having on the ability of visually impaired people to live independent lives. NCC is to prioritise enforcement of unauthorised obstructions on the highway and has produced guidance. Comments requested by 14th October 2016
- **O822. SIMPLIED FARES FOR YOUNG PEOPLE, STUDENTS AND APPRENTICES.** From 24th August Go North East are offering the following: a simple fare of £1 for all aged 18 & Under; the ability for parents to purchase tickets on their mobile and gift it to their child's mobile instantly or in advance; day ticket price frozen at £3.75; everyone in full time education regardless of age is eligible for our day, week and monthly student tickets.
- **O823. ANNUAL TOWN AND PARISH COUNCILS CONFERENCE.** The third Annual Town and Parish Councils Conference will take place on Thursday 13th October at County Hall, Morpeth. There are two identical sessions; afternoon 2-4pm and evening 6-8pm with a marketplace (4-6pm) of council services in between when refreshments will be available. Two delegates per council initially, with spare capacity offered nearer to the event on a first come first served basis. Booking can be made online, by email or booking form.

0830. VILLAGE ISSUES.

a) HORSLEY WATER WORKS - Northumbrian Water have some operational issues with the sludge plant at Horsley Treatment Works which may result in increased vehicle movements and noise levels for approximately four weeks. Tankers are currently taking sludge waste away from Horsley and this will continue for the next few days when temporary mobile plant will be delivered and set up on site on to support us while the situation is resolved. The mobile equipment will run from 7.00am until 7.00pm seven days a week and to minimise any impact to local residents, noise suppression measures will be installed while the equipment is in operation.
