HORSLEY PARISH COUNCIL

MINUTES OF THE MEETING OF THE PARISH COUNCIL HELD ON MONDAY 15 JANUARY 2018 AT 7.00PM IN THE WI/VILLAGE HALL

- **0978. PRESENT:** Cllr M D Senior, Chairman of the Council together with C Turnbull and R D Lillie In attendance: Mrs M Senior, Clerk to the Council
- **0979.** APOLOGIES FOR ABSENCE Cllrs C Roe, A Turnbull and S Lynch and County Councillor Karen Quinn.
- 0980. DECLARATIONS OF INTEREST. None.
- 0981. RESIDENTS.
 - a) BUS SHELTER. It was reported that the roof of the bus shelter on the eastbound A69 slip road had collapsed. Repairs will be arranged.
 - b) BLOCKED PUBLIC RIGHT OF WAY. It had been reported that the public footpath opposite Albemarle Barracks to Northside Farm was blocked with bricks and a locked metal gate. This had been reported to NCC however no action had been taken. This will be chased up with NCC.
 - c) GATE. It was noted that the gate between Dunslaw and Horsley Hill had been eaten away by the horses in the field. Cllr C Turnbull advised that he would speak to John Bramwell and look into it.
 - **d) GULLEYS.** The gulleys at the west end of the village are blocked. Although these had been reported in the past they will be reported again.
 - **e) TREE PLANTING.** Permission was requested to plant trees along Lead Lane to A69. The Parish Council have no objection to this.
 - f) FOOTBALL FIELD/PLAY AREA. The hedges had been cut back in the football field and play area although some growth was showing at the base of the hedges.
 - g) LIGHT POLLUTION. A resident from Horsley Wood Cottages had complained about the light pollution coming from the livery stables in Horsley. Clarification to be sought from the resident of the times that the lights are on and for how long.
- **0982. MINUTES.** It was proposed by Cllr R D Lillie, seconded by Cllr C Turnbull and AGREED that the minutes of the meeting held on **20 November 2017** be signed as an accurate record.
- 0983. MATTERS ARISING.
 - a) BUS SHELTER. Minute 0966a refers. It was noted that the bus shelter had been installed at Cherry Tree Gardens.
 - b) PLAY AREA. Minute 0966b refers. Northumbrian Water had been collecting information re new play area equipment at their drop in event. Unfortunately, Cllr A Turnbull was unable to attend the meeting therefore no update was available. The clerk will contact NWL for an update.
 - c) WAR MEMORIAL. Minute 0966c refers. A planning application to discharge condition 3 had been submitted and had been granted. Unfortunately, the contractor who was to carry out the repairs to the memorial had not responded to emails and telephone calls and therefore another contractor needs to be found. Northumbrian Water had offered to assist in finding a contractor and are to fund the repairs to the memorial. The clerk is following this up.
- **0984. COUNTY COUNCILLOR REPORT.** The email advising County Councillor Karen Quinn of the meeting did not reach her therefore she did not attend.
- **O985. CORRESPONDENCE.** All correspondence and information items received since the November meeting had been listed on the agenda and most of this correspondence had been circulated by email.
- **NOTIFICATION OF EXTERNAL AUDITOR APPOINTMENTS FOR THE 2017/18 FINANCIAL YEAR.** It was noted that the External Auditor for Horsley Parish Council for the financial years 2017/18 to 2021/22 will be PKF Littlejohn LLP.
- **O987. STREET LIGHTING MODERNISATION PROJECT UPDATE.** Following the recent operational and programme changes with the Street Lighting Modernisation Project it was noted that Northumberland County Council are working closely with the contractor to ensure that the remaining works are carried out swiftly with minimum disruption and in accordance with the project output specification.
- **O988. TEMPORARY ROAD CLOSURE ORDER C254 MAIN ROAD/C255 HORSLEY ROAD, OVINGHAM**. It was noted that a temporary road closure order will be in place from 5th February until 23rd February 2018 on the section of the C254 commencing 20m north east of its junction with Hillcrest, heading north east for 60m also encompassing a section of the C255 from its junction with the C254 heading north west for 50m. It is expected that the road will only be closed from 12th 16th February 2018.
