MINUTES OF THE MEETING OF THE PARISH COUNCIL HELD ON MONDAY 18 MARCH 2019 AT 7.00PM IN THE WI/VILLAGE HALL

- 1120. APOLOGIES FOR ABSENCE Cllr C Roe
- 1121. DECLARATIONS OF INTEREST. None
- **1122. UPDATE ON HORSLEY WATER TREATMENT WORKS UPGRADE.** Mike Foster and Richard Woodhouse attended the meeting to give an update on the upgrade of the Treatment Works. The commissioning stage of the works will commence shortly. The work should be operational by the end of the summer however cold weather testing will need to be carried out in January/February/March 2019 and the site fully operational by March 2020.

Lighting. Cllr S Lynch advised that the lighting on the site is on all day. Northumbrian Water advised that they are considering modifying the lights to create a dark sky approach.

Security fencing. It was noted that the security fencing is due to be installed in 2020. No trees are being felled. There needs to be a 3m exclusion zone from the fence. The contractors still need to agree the final landscaping of the site with the Planning Department and this will also include the mound. Once the existing site is demolished the mound will be distributed within the site. Northumbrian Water will come back to the Parish Council with a firm plan.

Play Area. Northumbrian Water had looked at options and a spider swing had been chosen by children in the village. The cost of these ranges from £5K to £12K. The Parish Council will obtain quotes from Kompan who have undertaken work in the park previously. Northumbrian Water agreed to meet on site to discuss the removal of the soil heap and old trim trail equipment. The Parish Council advised that there are only 7 years left on the lease with Northumberland Estates. A letter will be sent to Northumberland Estates asking if the lease can/will be extended.

Security Cabin. A security cabin had been placed at the gates for the usual period. This is to discourage the travellers passing through to Appleby from camping onsite.

Weekend working. The contractors will be working onsite over the next 3 weekends.

Donation. Northumbrian Water had agreed to donate some wooden seating in the Hearth Car Park. The Parish Council were happy to agree to this.

1123. RESIDENTS.

- a) FOOTPATH REPORT. It was noted that a new stile had been installed at Horsley Banks Farm which now restricted access for walkers with dogs. Access has been made more difficult by the positioning of three large flower tubs beside the stile. The official finger post marking the wat to the footpath from the main road has disappeared. Action: This had been reported to Tim Fish, NCC. The stile on the public right of way on the Ovingham Road is covered in brambles. Action: Tim Fish is to look at this within the next few days.
- b) STREET LIGHTING. It was noted there are still street lights in Horsley which have not been converted to LED. Northumberland County Council is currently in dispute with the street lighting contractor therefore work has not been completed.
- **c) HEDGES.** The responsibility for cutting the hedges along the edge of the football field and Water Lane was queried. This will be confirmed in due course.
- **1124. COUNTY COUNCILLOR REPORT.** Karen Quinn gave her verbal report on matters relating to Northumberland County Council.
 - a) DOG FOULING. A review of the Green Dog Walkers Scheme had been carried out and complaints are down by 30%.
 - b) SPEED SURVEYS. The speed survey is on the list to be carried out on Mill Way.
 - **c) MEMBER FUNDING.** Karen had agreed to fund new heating and windows in the Village Hall from her 2019-20 member funding.
 - **d) NEWCASTLE AIRPORT.** A meeting is to be held in the Knott Memorial Hall, Heddon on the Wall on Tuesday 19 March 2019 at 6.30pm with Newcastle Airport to provide an update on departure routes.

- **1128. TEMPORARY ROAD CLOSURE ORDER OATENS BANK.** Northumberland County have made an order to prohibit the use of vehicular traffic on the section of the C256 Oatens Bank from its junction with the B6318, heading south for 2400 metres. The order is to be effective from 27th February 2019 until 30th May 2019. It is expected that the road will only be closed from 11th April to 12th April between the hours of 9.00am and 4.00pm. The closure has been requested by NCC for carriageway patching.
- **1129. A69 STYFORD ROUNDABOUT.** Highways England has withdrawn the current proposals for the A69 Roundabout Works at Styford Roundabout. They will be consulting with local residents and Northumberland County Council to look at alternative design options in the future.

1133. VILLAGE ISSUES

- b) VILLAGE CLEAR UP. Several residents had offered to clear the paths at the west end of the village once the weather starts to improve.
- c) **TREE PLANTING**. It was noted that the Gardening Club had planted trees on the grass verge to the west of the Water Works entrance. Any tree planting needs the permission of Northumberland County Council and concerns were expressed as there are services which run underground along this section of verge. The Gardening Club will look to relocate the trees.
- d) H BARS ACROSS JUNCTIONS/DRIVEWAYS. County Councillor Karen Quinn advised that Northumberland County Council are not keen to paint H bars as they are ineffective and not enforceable. Any cars causing an obstruction can be reported to the police.
