MINUTES OF THE ONLINE MEETING OF HORSLEY PARISH COUNCIL HELD ON MONDAY 20 JULY 2020 AT 7.00PM (Draft Minutes Subject to Council Approval)

720.01 QUESTIONS FROM MEMBERS OF THE PUBLIC.

- a) Public Rights of Way. Maurice Holliday had sent in his footpath report which was noted.
 - b) Speeding. Several emails had been received regarding speeding in the village. A petition is circulating to be presented to the Parish Council at a later date. It was noted that the Community Speedwatch Scheme is on hold due to Covid 19. Speeding will be discussed in further details once the petition has been received. Signs 'SLOW CHILDREN PLAYING' were requested on Mill Way.
 - c) State of footpaths and roads. Complaints had been received by several residents over the poor state of the footpaths, roads and various road signs around the village. These had all been reported to NCC however due to the current pandemic only essential services are being carried out by NCC.

- **720.03 DECLARATIONS OF INTEREST –** Cllr C Roe declared a personal and prejudicial interest in item 0720.07b regarding planning application 20/01515/FUL.
- 720.04 MINUTES OF THE MEETING HELD ON 18th MAY 2020. It was proposed by Cllr M D Senior, seconded by Cllr C Turnbull and AGREED that the minutes of the meeting held on 18th May 2020 be signed as an accurate record.

720.05 ACTIONS ARISING FROM THE MEETING HELD ON 13TH JANUARY 2020.

- a) **Village Issues.** Minute 520.10 refers. The following work had been carried out since the last meeting.
 - 3 bus shelters in the village cleaned out. The bus stop opposite the Crown and Anchor had been pointed.
 - 2 litter bins installed at the east and west end of the village.
 - Goal posts painted and new nets bought.
 - Play area repairs carried out including: Zip slide seat replaced; all equipment cleaned; skate ramp surface part repaired; bird deterrents installed on toddler swing frame; all fixings checked and replaced where necessary; climbing frame had been cordoned off due to unsafe climbing area.
 - NCC have replaced, repaired and renewed various signs around the village.
- 720.06 CORRESPONDENCE received since the May meeting had been circulated to all councillors by email and noted.
 - a) **WILDFLOWER VERGES.** A request for the grass verges to be left as wildflower areas was received. This could only be achieved in certain areas due to the 3 year grass cutting contract. The Parish Council agreed in principal to certain areas being turned into wildflower areas and will look into this further.
 - b) **HERBICIDES.** Email received from a resident expressing concerns over the use of glyphosate on the neighbouring fields. The local farmers do use glyphosate during July and the resident has requested an alert system to be set up. It was agreed that Cllr C Turnbull would advise when he was to spray the fields and Mrs Senior would advise the residents accordingly.

720.09 VILLAGE ISSUES

- a) REPORTS ON VILLAGE ISSUES AND HIGHWAYS MATTERS
 - **Mill Way.** It was noted that NCC was carrying out drainage work along Mill Way. This will improve the water running off the fields.
 - **Gulleys.** Mrs Senior is keeping in contact with NCC who are to advise when the gulley wagon will visit Horsley.
- b) TO RECEIVE PLAY AREA INSPECTION AND AGREE WORK IDENTIFIED. The Annual Play Area inspection had been carried out by RoSPA and various repairs had been identified. It was noted that the ramp and climbing wall on the large climbing frame had warped and some of the timbers had rotted. The cost to replace the various sections £2232 + VAT. It was proposed by Cllr Mrs S Glover, seconded by Cllr C Turnbull and AGREED to repair the climbing frame. This would be a considerably cheaper option than having to replace or remove the old equipment.

It was noted that the skate ramp has a 5mm transition between the ramp and the tarmac. This will need to be rectified. Cllr S Lynch to look into getting this repaired.

LITTER PICK. It was noted that several residents have adopted sections of the village and pick up c) litter in these areas regularly. Thanks were expressed to all residents involved. Litter picking equipment is available to all residents, if required.

- a) **OVINGHAM JOINT BURIAL COMMITTEE.** The next meeting is to be held in the cemetery on Tuesday 21 July 2020. The groundworks contract had been awarded to Adrian Jackson for the coming 3 years. Stability testing is due to be carried out and some works on the trees which are overhanging neighbouring properties.
