## CADEBY PARISH COUNCIL

Minutes of Parish Council Meeting held Thursday 19<sup>th</sup> January 2023, 6.30 p.m. At The Church Hall, Cadeby.

PRESENT: Councillors: J Lane (Chairman), I Smith, D Winterbottom.

Other Attendees: Angela Forsyth (Clerk), Borough Cllr M Cook, 1 member of the public.

The meeting began at 6.45 p.m.

**23/001: WELCOME, ACCEPTANCE OF APOLOGIES FOR ABSENCE**: Cllrs Freeman and Karkowski had sent their apologies for personal reasons which were accepted.

**23/002: DECLARATIONS OF INTEREST BY COUNCILLORS:** Cllrs Smith and Lane declared being trustees of Cadeby Community Trust which had submitted an invoice.

**23/003: APPROVAL OF PREVIOUS MINUTES SIGNED:** The November meeting minutes were agreed and signed by the Chairman.

**23/004: BOROUGH COUNCILLOR REPORT**: Cllr Cook reported efforts to have a severe rut in Cadeby Lane rectified by LCC, this is ongoing. The driveway to a property on Church Road which encroaches the highway has also been reported to LCC. HGVs and a 52-seater school coach are increasingly using the Cadeby Lane as a cut through which is eroding the lane and is a recognised hazard. HBBC's Local Plan is delayed until at least 2025.

## 23/005: PLANNING APPLICATIONS:

22/01177/FUL: 1 Boston Sidings, Bull In The Oak. Observation comment - the vehicle tracking
details do not demonstrate vehicles negotiating the new access to the field. Having entered into
the dwelling access from the highway, they would have to reverse out again onto the highway to
reposition and manoeuvre again into the new access. This will cause significant hazard and
disruption to a busy junction.

**23/006: CORRESPONDENCE**: The Clerk had circulated a report prior to the meeting:

- An invitation from Market Bosworth Chairman for councils to attend a meeting to discuss the impact of the HSBC bank closure, Cllr Winterbottom offered to attend for Cadeby PC, if he is able to attend
- Highways had circulated notice requirements for any proposed road closures to occur during coronation events.

**23/007: CLERK UPDATE**: Clerk had circulated the action report on actions taking over the role of this Council's Clerk.

**23/008: MEETING SCHEDULE**: Due to the new Clerk also clerking for Witherley PC and its meetings also scheduled for second Thursday each month, the Clerk requested this Council change its meeting dates. It was agreed Cadeby Council will meet on the third Thursday monthly, with the exceptions of August and December when there will be no meeting.

**23/009: 2023/24 BUDGET:** The Council reviewed current and previous expenditure, took into consideration increasing costs and necessary reserves and agreed the budget of £5,600.

**23/010 2023/24 PRECEPT**: The Council agreed to cover the 2023/24 expenditure with the precept of £5,600. This equates to £50.67 per household (average calculated at Band D level) for the year.
