This Month's News:



As the government guidelines continue to change we are challenged with enforcing the restrictions, we encourage residents and business owners to follow rules on social distancing and wearing face coverings. We are dealing with reports of COVID breaches and issuing penalty notices, when there is clear evidence of a breach. Enforcement action in relation to breaches by businesses will be led by local Authorities (Environmental Health Officers & Trading Standards). Overall the compliance of regulations in Market Bosworth & Surrounding Villages has been acceptable, and individuals have adapted well. We hope to educate those who do not comply, and remind them that the FPN (Fixed Penalty Notice) now stands at £1,000 payable within 28days, reduced to £500 if paid within 14 days.

Throughout the month we have supported our NPA (Hinckley & Blaby) with the execution of several drug warrants, which have led to many arrests. The success of this operation was undoubtedly down to the intelligence provided by local residents. This shows the importance of 'speaking out' about any concerns you may have regarding individuals and their behaviour. So thank you!

Also this month we supported the return of 25 schools on NH29 beat. Returning to school is vital for children's education and wellbeing, and parents and teachers have embraced the government restrictions. We must however remind vehicle users travelling to-from our schools to remember Road Safety, with an average of 70 people per day (2018) seriously injured on British roads, now more than ever do we urge you to THINK about your actions on the 'School Run'. Do everything you can to avoid collisions and casualties.

What we did:

We have continued to address reports of Anti-social behaviour in Groby. The individuals have been identified and we have issued several warning letters. Home visits have been carried out and advice given to parents. Contact has been made with the Head of Year at Brookvale Learning Campus, discussions have led to highlighting key 'gathering' areas in the parent's newsletter. Local Youth Volunteers have offered to engage with the individuals, as part of a 'Community Resolution'. Beat officers will continue to patrol the area, and also monitored by partnering agencies such as HBBC ASB team.
