- 1] APOLOGIES FOR ABSENCE Cllr Mike Bylina
- 2] DECLARATIONS OF INTEREST There were none
- 3] MINUTES FROM PREVIOUS MEETING ON JULY 29, 2019 were accepted as circulated and signed by the chairman
- 4] DEFIBRILLATOR AND CPR TRAINING The matter was to be an agenda item for the next meeting.
- 5] PUBLIC FORUM 10 MINUTES Comment was made on the need to have grass alongside the main road through the village near the electricity sub-station cut, with some of the overgrowth already spreading out on to the pavement. Coun. Cottee said he would take the matter up with the highways department.
- 6] CLERK'S REPORT AND UPDATE ON PREVIOUS MEETING BUSINESS Nothing that is not covered on the agenda.
- 7] REPORT FROM THE BOROUGH AND COUNTY COUNCIL MEMBERS
  Coun. Cottee reported that there was to be progress on provision of a roadside pavement on Bradmore Lane leading from the Griffin Inn to the cricket ground and hoped it might come about in October.
  He informed the meeting of a new £1.75m vehicle that was now in use to tackle highway pot hole problems.
  The Borough Council 's Local Plan Part Two was due to be presented for approval at a special meeting in October.

# 8] CORRESPONDENCE

Nottinghamshire County Council free bags of salt scheme was again operating but members felt there was currently no requirements they had.

Rushcliffe Borough Council tree offer for parishioners; the council were to apply for the ten free trees for Lottie. CPRE spelt out its new strategy on its future, explaining it was tackling a drop in membership.

Burnside Hall wrote seeking grant to help towards the £7000 it had recent[ly] had to spend dealing with structural problems with the building. Members agreed to give £500.

Plumtree parish council website visitor analysis report April to August showed a continuing numbers of visitors of over 100 a month.

National Audit Office presented a consultation on a new Code of Audit Practice for parish councils to operate. Nottingham County Council gave notice of roadworks on Station Road to tackle a water mains repair.
