## **Traffic Management Survey**

## **Background**

The Community Council has had concerns raised about the issues caused by poor parking and lack of parking, in the village, on the trunk road and at Dornie Hall.

We, and managers from Eilean Donan Castle, met with representatives from Highland Council in September to start discussions on how things could be improved. There are still to be meetings involving the police, Bear Scotland and Transport Scotland (they deal with the A87) and we wanted to ensure that all members of the community have an opportunity to give their views.

The first stage is this survey asking for views, recommendations and ideas. We will hold a meeting in Dornie Hall on Wednesday 19 February to take proposals to the next stage. ## Parking in the village

The introduction of the pavement parking ban has caused even more problems with management of parking in the village. Since November last year, it has been illegal to park on pavements. Highland Council officers said that areas affected include Brookside – despite this originally being created for parking, the front of Dornie Hotel and the paved area with benches opposite the hotel, and the area round the Clachan B&B (green highlighter).





Some of the suggestions for addressing this from Highland Council officers included:

**Yellow lines** to indicate where parking is not allowed. A single line would permit the school bus to pick up and drop off passengers.



**Permits** (at a cost, currently £40 per year) for residents of Francis Street and Brookside to ensure that they have access to parking:



**Double yellow lines** on the entry to the village:

# **Dornie Hall car park**

It is clear that the volume of traffic using the car park is causing problems and safety hazards, with buses seen reversing onto the trunk road, parking on the trunk road and some overflow traffic from Eilean Donan Castle when their car park is closed.

This photo was taken probably in 2007/8 as the hall roof is being worked on and it doesn't show the lines for parking.



**Some suggestions** from Highland Council on how to make better use of this car park:

- 1. Reline car park
- 2. Compulsory payment instead of voluntary for both car park and toilets. The income from this might be enough to pay for a car park attendant during the summer. Someone on site would help manage the traffic better.
- 3. Reduce amount of disabled bays there are more than are required by law
- 4. Marked-up bays should help to exclude oversized vehicles
- 5. One more pay and display machine
- 6. The car park at the rear currently blocked off for functions, could be utilised and blocked off only when there are functions. This would be beneficial if the car park becomes compulsory payments

The income from the car park in 2023/24 was only £1,177.

## **Eilean Donan Castle Car Park**

We appreciate that this is entirely within the control of Conchra Charitable Trust. However, it is recognised that some of the parking problems in July and August stem from the high number of tourists who want to visit the Castle. The Trust has created overflow parking at Eilean Donan Apartments and advised that they have increased the parking areas at the Castle and at the Apartments and are investigating electronic signage such as the Highland Council suggested at the meeting in September.

## **Castle Viewpoint**

Another issue discussed was the problem with people parking at the Castle Viewpoint on the Carr Brae road who use the area as a toilet. Highland Council suggested one way to prevent this was to use a Passing Place sign as in the picture:



### Traffic and the A87 Trunk Road

This year, Scottish Ministers allowed a clearway on the A87 for 1.6km on either side of the Castle car park. This meant that no vehicles were allowed to stop on the road. It was a temporary measure, in effect from 4 April to 4 October 2024.

The reason was:

Scottish Ministers are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited because of **the likelihood of danger to the public**, or of serious damage to the road, which is not attributable to works.

The Community Council has discussed asking for a speed limit of 40mph on this stretch of road.
