(c) Inter Parish Working Group on Housing/Eton College Site/Lewes District Council Local Plan/South Downs Local Plan:

Consultation is also being undertaken on the East Sussex Transport Plan. Councillor Tickner will draft comments on the Lewes District Council Local Plan for circulation to members by 20th January, to enable a response to be submitted by the consultation expiry on 8th February 2024.
