### PUBLIC PARTICIPATION

- 131/19 Nigel Palmer from Market Bosworth Historical Society introduced the archaeological and community based project called Bosworth Links which was held in 2016 to find out more about the history of Market Bosworth. The project is looking to extend its coverage to include villages around Market Bosworth, including Sutton Cheney and Shenton. It was advised that the Society approaches the estate owners of each village to seek the relevant permissions before the Council can get involved.
- 132/19 A member of the public was encouraged about the sourcing of a long term solution to Rose Bank and is keen to work with the Council.

### PREVIOUS MINUTES

- 135/19 The Council unanimously resolved to adopt the draft minutes of the Parish Council Meeting held on 12<sup>th</sup> June 2019 with no amendments.

### BOROUGH AND COUNTY COUNCILLOR REPORTS

- 136/19 The Council noted the report from County Councillor Ould and Borough Councillor Collett. The Council requested that the Clerk contact HBBC asking why they were not asked to attend the recent exhibition in Market Bosworth.

### COUNCILLOR VACANCY

- 137/19 One application was received for the vacancy of Parish Councillor for Sutton Ward. It was unanimously resolved that Pamela Tebbatt Mills to be co-opted onto the Council. She was observed by the Clerk in signing her declaration of office.

138/19 One application was received for the vacancy of Parish Councillor for Shenton Ward. It was unanimously resolved that Charles Woolaston to be co-opted onto the Council.

#### **FENCE ON ALLOTMENT**

139/19 It was unanimously resolved to permit the tenant their request for a temporary fence around plot 1B and 2A on condition that it is completed within 6 months and that it must be completely removed from site upon the termination of their tenancy.

#### **HANDYPERSON**

140/19 It was unanimously resolved to advertise for a handyperson to work on a flexible and ad hoc basis for the Council to undertake general maintenance work across the Parish.

#### **ADOPTION OF BT KIOSKS IN SUTTON CHENEY AND SHENTON**

141/19 It was unanimously resolved to adopt the BT Kiosks in Sutton Cheney and Shenton following the BT consultation exercise.

142/19 It was unanimously resolved to request the Clerk to investigate ways in re-landscaping Rose Bank.

143/19 It was noted that no funding update had been received and that the Clerk was asked to investigate prior to a formal complaint being made on behalf of the Council.

#### **MEMBER REPORTS**

- 151/19 Cllr Mayne had attended a recent coffee morning in Sutton Cheney which mentioned the restoration of Sir William Roberts tomb, as well as the rural heritage trail which will highlight points of interest around villages. Around 10 people are interested in developing one in Dadlington and possibly Sutton Cheney. Any further updates should be sent to the Clerk in order to promote it through the Council.
- 152/19 The 1485 Sculpture Trail Steering Committee met recently in Market Bosworth as they are not happy with what is being proposed. The Council repeated their concerns regarding the lack of parking and infrastructure to support such a scheme. Market Bosworth do not want it in the Parish Field, nor the Country Park so the new proposal includes a “letter tree”. Cllr Mayne to send further details to the Clerk for wider circulation.
