51/22	<p>PUBLIC PARTICIPATION</p> <p>A member of the public raised an issue with the Council's code of conduct and correspondence from Cllr Dyde. Cllr Copson stated that the matter will be passed to Clerk.</p> <p>A member of the public stated that they were keen for the Council to adopt the Neighbourhood Plan urgently.</p> <p>A member of the public commented that the alleged conflict of interest is not relevant to the Neighbourhood Plan as the planning document is not concerned with ownership. They urged the Council to adopt the Neighbourhood Plan.</p> <p>A member of the public stated that the item on Dadlington Village Green was undemocratic with 2 Councillor vacancies for Dadlington Ward.</p> <p>A member of the public raised queries over the User Agreement for Dadlington Village Green. The Chair answered that the agreement would go out to consultation for the public.</p> <p>A member of the public stated that the User Agreement was a reasonable document as long as it not enforced on dog walkers and members of the public.</p> <p>A member of the public asked whether a covering letter will be drafted and adopted by Council in connection with the User Agreement. The Chair answered that the Clerk will draft an explanation of why the consultation is taking place.</p>
