183/22	<p>PUBLIC PARTICIPATION</p> <p>A member of the public appealed to the Council to uphold Policy D2 in the Neighbourhood Plan and to keep the area of separation between Dadlington and Stoke Golding.</p>
184/22	<p>A member of the public complained about the hedge not being maintained correctly in Dadlington Churchyard as you can't see the noticeboard. The Chair explained that the grounds maintenance contractor had terminated the contract with the Council and that the handyman had taken over the work until the end of 2022. He will be informed to make this a priority</p>
185/22	<p>A member of the public commented that they are applying to the diocese for the internment of ashes</p>
186/22	<p>A member of the public commented that the pipe organ at Dadlington Church needed to be repaired and that the village were active fundraising £6000</p>

189/22	<p>PREVIOUS MINUTES</p> <p>The Council agreed to adopt the draft minutes from the Parish Council Meeting held on 6th September with no amendments made.</p>

190/22	The Council noted the amendment to the Parish Council minutes held on 14 th July to read “Cllr Rees Jones asked Cllr Pritchard about where the photos were being stored and what their use was. Cllr Pritchard replied that the Parish Clerk had told her that this subject was not up for discussion during members reports”.
191/22	BOROUGH AND COUNTY COUNCILLOR REPORTS The Council noted the reports from Cllr Collett and Cllr Harrison-Rushton.
192/22	CLERKS REPORT The Council noted the Clerks Report
193/22	DADLINGTON NEIGHBOURHOOD PLAN The Council noted an update from the Chair of Dadlington Neighbourhood Plan Committee. The Committee are waiting for Hinckley and Bosworth Borough Council to complete the Strategic Ecological Assessment stage after which point the Regulation 14 consultation can begin. The Chair of the Committee confirmed that the SHEELA and area of separation remains a priority to safeguard in the plan.
194/22	SHENTON HERITAGE STREETLIGHTS The Clerk gave an update on Shenton Heritage Streetlights The Council agreed to accept the quotation from Leicestershire County Council Highways to upgrade all of the 4 heritage streetlights in Shenton to LED upgrades
195/22	SUTTON CHENEY PLANTERS The Council agreed to adopt the two Sutton Cheney planters on Wharf Lane and Bosworth Road in Sutton Cheney from the William Roberts Charity pending a licence from Leicestershire County Council
196/22	SUTTON CHENEY DEFIBRILLATOR The Council noted an update from Cllr Pritchard on the Sutton Cheney Wharf defibrillator project. Cllr Cartwright launched the event and it was thanks to him for the PCIF grant to enable the project to happen. It was well attended and tea and coffee offered by Sutton Cheney Wharf café. The next stage is now organising the training event.
197/22	The Council discussed that the training event should take place at Sutton Cheney Wharf as it can cater for 40 people. The Clerk will liaise with the owner to agree a date to publicise locally. Cllr Plant suggested wider first aid training which could be incorporated. The Clerk to check further details.
