Keep Britain Tidy - cleaning up for Queens $90^{\text {th }}$ birthday. It was agreed to join the national day being staged in March next year between the $4^{\text {th }}$ and $6^{\text {th }}$.

10] AMENITIES
Carruthers Solutions of Edwalton gave a Quotation for a web site in the sum of $£ 48995$ to design and provide and an annual fee of $£ 27995$. The council agreed to proceed with the order for the website to be established. The council wished to see the full name Normanton on the Wolds in the domain name.
The clerk was asked to contact both Notts County Council and Rushcliffe Borough Council in regard to the amount of weeds growing at roadside kerbs. If they were not going to attend to them a price was to be obtained for the work from Streetwise and the Council's own contractor.

It was agreed prices for provision of planters be obtained, with a suggestion for them to be sited on Clipston Lane and the Nottingham end of Old Melton Road. A footpath walk would be organised for October 11 at 10:30am starting from the phone box and suggestions could be made at that in regard to any other sites for planters.

11] SOCIAL EVENTS
Plans had been finalised by Coun. Shipside for the Village Boules Challenge match on October 8, at 6:30pm. Four teams to represent different areas of the parish would take part in the event at the Plough's own boules square. Drinks would be served at the Plough from 6:30pm and the games would start at 7:00pm. The games would be at 8pm when food would be served.
The council agreed to allocate up to $£ 200$ towards cost of the event.
The council agreed that it would investigate plans for a village celebration event next June in connection with the $90^{\text {th }}$ birthday of HM The Queen.

The chairman reported he had received comments from residents in regard to use of Back Lane by heavy goods vehicles. He also reported a number of pot holes on that lane and said he would report them to Notts County Council.
