## 6] CORRESPONDENCE

Rushcliffe Borough Council Community Assets –Plough Inn. The Borough Council advised it had accepted the request from CAMRA to declare the public house a community asset. Coun. Hughes, as licensee at the Plough, said he knew nothing of the application.

Local Government Boundary Commission, electoral review of Nottinghamshire was now complete and showed that Normanton on the Wolds would be in the single member Cotgrave seat at future Notts County Council elections.

Notts County Council Paula Johnson had responded to a question raised by the chairman on the speed signs in the village. After consideration of her comments the clerk was asked to write to seek the cost of replacement of the current combined village name and 30mph sign with a simple speed sign.

Scott Cairns, a resident on Clipston Lane, wrote to make a heavy traffic complaint. The clerk was asked to seek comment from Notts County Council on the possible provision of passing areas to reduce the need for vehicles to drive on to the roadside verges and cause damage to them.

A letter was received that had been sent to all parish councils suggesting a Bonfire Beacon event for the Queen's 90<sup>th</sup> birthday, April 21. The council agreed to organise an event and to purchase a Beacon which would be used.
