# Item 7a: December Forestry Report

Following the storms on 7<sup>th</sup> October, A&B repaired the culvert at the .bottom of Station Road. They reported that this had been blocked by a hanging basket which had found its way into the burn. The revised TTMP, dated 4<sup>th</sup> August 2023 was finally posted on the A&B website on 17<sup>th</sup> October. The ATTG contact is listed as Iain Catterwell who is no longer in post. No replacement has been appointed.

The cutting down and removal of the larch trees infected with Phytophthora Ramorum started in mid October. This highly destructive algae-like organism causes the death of a wide range of trees and shrubs, not just larch, although this is where it has had its greatest impact in the UK. Trees in the wetter parts of the UK are most susceptible, because the pathogen requires water to spread and infect its host. Scottish Woodlands have chosen not to post the bio-security poster available to download from the Scottish Forestry Website advising the public to clean leaves and mud off shoes and bicycle tyres but we are assured that the forestry workers are following strict bio-security guidelines.

There have been 3 reported breaches of the TTMP so far; two involving vehicles travelling outwith the allowed times, and a third, before 7am on 9<sup>th</sup> November, involving a empty timber truck and trailer unable to make the turn at the roundabout between Pier and Station Road. For the record it takes just over an hour for timber truck to load and return down Pier and Station Road.

Three local residents have contacted the Community Council with concern about the proposed commercial woodlands at Letrault and Stuckenduff. They were all advised to contact Mike Page. One has met with Mike Page and received assurances that existing access will be maintained and drainage will be considered carefully to avoid contributing to the existing flooding problems already faced by Shandon residents. There are also concerns about planting on the deep peat land and the protection of archeological features.

Possibly as a result of the above interventions, Scottish Forestry has informed the Community Council that an Enforcement Order has been issued to Scottish

Woodlands. No further road building work to be undertaken until screening option has been issued. Grant funding for fencing work already done is being withheld.

**Report from the Emma Gray from Scottish Forestry** who is the Operations Area Manager covering Argyll, Loch Lomond & Trossachs National Park.:

"Letrault & Stuckenduff;: We received an updated copy of an archaeologists report on Thursday, 7<sup>th</sup> December. We are in the process of reviewing the information from this report with a view to make a screening opinion decision once we are satisfied the advice and request cover the outstanding issues".

### **Other Timber Transport Issues**

A loaded timber transport vehicle was observed entering A814 by the County Hotel. We assume that this had travelled down Sinclair Street and turned into King Street West, most likely coming from the Bannachra Muir, commercial woodlands beyond Blackhill, which is being managed by Scottish Woodlands. I reported this to Raymond Kane who asked for details of date and time.
