Topic	Decision/ Action
1. Apologies:	Apologies were received from CC members Jim Duncan, Linda Duncan, Linda Black, John Clark, Derek Hall, and Tim Lamb, Cllrs George Freeman and Iain Patterson and Mark Fitzsimmons (MF) from HMNB Clyde. Those attending the meeting introduced themselves and were welcomed by the Chairman.

MDP Report: PC Drew Omand, the new Defence Community Police Officer (DCPO) for the Churchill and Helensburgh Defence Estates including Smuggler's Way, outlined his Report which is posted on the website.</p> <p>He drew attention to the increase in the number of drones, particularly in sensitive defence areas, and asked that the public should report sightings to HMNB Clyde Control room (Tel 01436 655765) giving details of time and place and a description.</p> <p>He noted that the Peace Camp celebrates its 40th Anniversary in June 2022 with a month-long series of events.</p>

10.Consultations:	
Empowering our Educators. Our response is posted on the Archived Consultations page of our website.	
We did not respond to the consultations on the HSBC Budget, Pavement Parking or Free Period Provision.	
13. Green Island Felling 20/02183/FELLIN	
In our submission in December 2020, we asked that the logging vehicles should not travel along the A814 through Rhu Village.	
Howard Young explained in an email that in such applications the Council is a consultee and not the decision maker. They are consulted to identify if the trees are protected by TPOs. Scottish Forestry would consult separately on other issues which they did not do. He denied that our representation had been ignored and no-one bothered to tell us that we had to contact SF. He said that they do not usually pass on third part comments to SF. It was up to us to talk separately to Roads. He agreed to look back and see what procedures were involved. Watch this space!	
On the same issue Iain Catterwell said there was no difference between a logging truck and an HGV and there is a presumption that the TTMP will use the A814. He suggested that the TTMP drawn up in 2014 when the last logging here took place will still be in use. I have not been able to access this.	
Whether a TTMP is required is at the decision of the Council, since these are concerned with the state of roads, not road safety. LF thought she may have a copy of an existing TTMP for this forest and will forward it to the Secretary if she has.	
Post meeting note: LF forwarded TTMP and a letter has been written to IC. Further investigation is needed here. FB reported that for the forthcoming felling in Highlandsman and Torr and for the Road Building in Letrault and Stuckenduff, the previous	Action LF

TTMP will have to be revised following a consultation with the community.

JC met with Fergus Madigan from Garelochhead and Norman Muir from Helensburgh to consider collaboration on common issues that many CCs have with A&B. Another meeting will be arranged. FB suggested that maybe we should request a meeting with officers of the Council.

7.Planning Matters

7a: RHU LODGE 21/02709/PP: Variation of Road Conditions at Ferry Road

This application is in response to the approval for a single dwelling house which required some changes to Ferry road. The owner objected to the improvements required for Ferry Road and suggested others. The CC objected. We asked that the Planning and Roads Departments would consider whether the conditions attached to Planning Applications 16/02043/PP, 16/01491/PP and 20/01150/PP, described as Residential Properties in their applications, are appropriate for what has evidently become a series of commercial developments at Rhu Lodge. The owner of Rhu Lodge had lobbied pedestrians who use Ferry Road suggesting that the road would change dramatically unless his proposal was approved. Since this is essentially a road usage issue, our Objection provided evidence in the form of links to websites of the commercial nature of activities at Rhu Lodge of which Planning are unaware. By Monday, the links we had in our objection were all unavailable, but fortunately we had screen shots so were able to resubmit with screen shots instead of links. This application is still "Awaiting Decision".

7b: Ferry Point Change of use

Following our submission **to the above**, and after several reminders, Howard Young confirmed on 12th April that an enforcement case on Change of use has been opened on 16/01491/PP and they are in the process of collecting information before taking action

7c: Demolition of Workshop and Erection of Replacement Workshop/Store:19/02479/pp

This planning application is for the removal of a single story wooden building of height 3m at its highest point and its replacement by a two storey structure of height 5.65m, higher than the two nearest buildings in Inchgower Grove, a modest increase in height according to the application. This structure was a joinery workshop in the 1950s. Because it is in a conservation area, there is a presumption for replacing like for like. It was agreed that the application is flawed in many respects. Two of the four neighbours are directly affected have found that this application is impinging on house sales. It was agreed that the Planning Subcommittee should investigate this further and take what action they see fit in attempting to get this application reconsidered. It was also suggested that advice should be sort from PAS.

7d: Duneira 19/01573/PP Change of use from Dwelling House to

Residential Training Centre.

This was approved in January 2020 subject to conditions. The owner appealed against these conditions. No reply from Howard Young in response to the receipt of the half dozen links demonstrating that the property was in fact, being used for short- term lets, until today."The matter is being investigated and the department will endeavour to send a reply within 28 working days".

8.Other Matters**8a:Road Safety Campaign**

The email roadsafety@rhuandshandoncommunity.org has received no reports but AM reported that his campaign on the Rhu Bay Face book page had generated 70 to 85 responses. Despite attempts and promises, the reporting system to A&B is flawed and many residents feel that they have been let down by A&B. AM registered a complaint about the reporting system and this was upheld The project manager at Roads and Infrastructure accepts that there is a problem but, despite promises, has yet to take any action.

8b:Forestry Issues

FB proposed that the CC write a formal letter of complaint to Scottish Forestry(SF) copied to Jackie Baillie and Marie McCallam, the Minister for Forestry, about the shambles of the consultation which we have been subjected on Letrault and Stuckenduff (L&S). On 7th May 2021, when we were informed that the grants had been awarded, we responded to say that the planting looked better but could we have up-to-date copies of the Operational Plan and the Issues Log. We asked Scottish Woodlands(SW) and SF again in November and in February this year and finally FB asked Doug Howieson, Operations Manager at SF on 9th March. A reply from the latter blamed Covid but assured us they were working on it. He said that only one representation had been received by SF on these proposals, We know this to be untrue. Iain Catterwell (IC) has said that because of the minister's position he hoped that L&S would be the last of the old bad consultations. We would like it to be the first of the good ones!

Marie McCallum spoke at a recent CONFOR meeting and said that communities are no longer to have Forestry "done to them"; they need to be consulted and there needs to be community benefits. In a reply to a question from English Forestry, SF explained that they were able to progress so many applications because they had reduced the need for an Environment Assessment (EIA) to only 2%. L&S did not have an EIA. .Many issues have been ignored; wildlife in burns, short eared owls, etc We now know that future coups from H&T will be smaller, 10 to 12 thousand tons instead of the recent harvest of 30. Harvesting will take place every two years from 2022 to 2035. There will no logging between 2035 and 2055 when all three properties will be productive. He said that explorations on the potential for an alternative timber route have been undertaken and at this stage are not viable.

A meeting of active parties to discuss a strategy for action. We might also consider consulting PAS.

It was noted that other Community Councils in Dumfries and Galloway are similarly affected.

Finally it was agreed unanimously that the formal letter of complaint mooted above would be sent.

8d:Future of Bowling Club site

A registered letter was sent to Messrs Prow and Carr to ask if they would consider transferring or selling this piece of land to the Community. A reply was received which has been circulated. The answer was a very definite "no". They made it clear that as far as they are concerned the matter is closed.

The demolition application for the existing structure has been applied for. WM reported a thwarted attempt made by the owners, to force entry into the site via Inchgower Grove, which would have involved making holes in a brick wall, beech hedge and fence. Police Scotland and A&B have been informed.

8e: Shandon TPO.

Nothing to report.

8f:Planning Advice Scotland(PAS)

Information about this has been circulated PAS offer advice, talks and training.

It was agreed that we invite them to give a talk first and then arrange a training session.

8h: Sewage in Rhu Bay

This current outflow was been reported to Scottish Water and to SEPA. As of today the immediate problem has been solved but it is likely to return. It seems to be related to problems with the sewage from Rosslea Hall. Hotel. The next time it happens, we will contact SEPA and ask them to confirm that the Septic Tank at Rosslea Hall is fit for purpose.

Post meeting note. For the record, the last time the CC was involved was in Jan 2019. There was also been an outflow in October 2018. Both of these were reported to Scottish Water and SEPA and the Environmental Health Officer was at the time. .

He is still aware of the footpath problem on Pier Road.</p>		
13. Member's Reports	<p>JC on behalf of LD. Concern has been expressed at the number of temporary orange fences which are in Rhu. Three along the bay side, some of which are very insecurely attached and downright dangerous and a strange one outside Rhu House where the actual fence is intact. This one is particularly poorly attached. The others are in places where the existing fence has rotted away and is unsafe. There is also another behind the bus stop between Pier Road and Artarman Road, which is in front of a lamp post which has rotted away, and is lying by the wall. Both LD and AM has already asked that these be removed. Both have incident numbers.
