1. APOLOGIES:

2. DECLARATIONS OF INTEREST

3. **GUEST REPORTS:**

a. **POLICE REPORT**. Emailed by PC Craig Cormack. The report is posted on our website. In summary, there were 37 calls to the police.

Crime Reports raised: one each for fraud and theft, two for vandalism, one for threatening and abusive behaviour, one for assault and three for drug possession. There were seven related to road safety and road crime, five of which were dealt with fixed penalty notices and two for a vehicle failing to stop

b: HMNB Clyde. Report by Cdr JF

- There are no significant events to report.
- The problems with culverts are progressing slowly. Clyde Coast Cutters have been contracted. The work is expected to be completed by Christmas.
- Captain Paul Barker is working on reducing the car journeys to the Base. Improving active travel routes is an essential part of this. Councillor William Sinclair, A&B Armed Forces Lead is involved.
- Cdr JF will attend the next meeting of H&LCPG on August 19th.
- Cdr Nick Stewart (CdrNS) is taking over as Base Executive Officer in September.
- Cdr JF hopes to attend the next CC meeting along with CdrNS.

The MOD is concerned with reducing the number of car journeys to the base. Residents of Rhu are concerned with reducing the volume of traffic travelling on the A814. One way to persuade commuters to use the A82 rather than the A814 would be to improve the junction of the A817 and the A82, ideally by means of the installation of a roundabout.

At her recent surgery, JM raised this issue with Jackie Baillie.

4. MINUTES OF THE MEETING HELD 11TH JUNE 2025

- The Notice Board has been erected and is in use. RS will contact the contractor about a suitable heading, similar to the one on the nearby Church board.
- Defibrillators. The Rotary Club is still working on this. However we have posted the location of the three local public defibrillators on the Notic Board. Ardencaple and the Rosslea Hotels both have defibrillators and it will be confirmed that these two organisations are willing to have these two locations added to the list.

Raymond Kane has confirmed that he will schedule his team to carry out the necessary improvements works as soon as possible consistent with other scheduled commitments.

6. PLANNING MATTERS

The Planning group submitted an Objection to Dilmun and a Representation to Dalarne. These were circulated and will be posted

25/01280/PP&25/01260/LIB: DEVELOPMENT OF COURTYARD INCLUDING ERECTION OF DWELLING HOUSE, RESTORATION OF EXISTING GARAGE AND FOLLY STRUCTURES.

Given the problems of drainage and runoff in Shandon and the extra turnoff traffic that this further development of the property would bring to an already very dangerous section of the A814, it was agreed that the Planning Group would consider this application.

7. FORESTRY AND RELATED ISSUES

• Timber Transport. The agreed letter on issues resulting from the diversion of traffic due to the closure of the lower section of Pier Road was sent to Raymond Kane and Mike Page (MP). The reply from the former included "we will always endeavour to permit works within the carriageway out with the noticed timber extraction periods discussed, to minimise any and all associated hazards". He added that the previously undertaken works were done without their knowledge or consent.

MP replied immediately to say that, in future, as soon as they hear anything from Argyll and Bute, they can change their plans to accommodate. He asked how the timber transport is going from our point of view; i.e. do we have any specific complaints or problems that they can address?

In the discussion which followed, it was noted that there ought to be contingency plans in place, in case an accident closed Pier or Station Roads. There have been reports of a couple of unloaded truck going up Pier Road before 6am and there have also been several reports of loaded trucks exceeding the 20mph speed limit. The latest report was on 11th August. It was agreed that this information be relayed to MP and the community reminded of the details in the Timber Transport Management Plan and asked to report contraventions. The issues of safety are paramount and the report of a mobility scooter and loaded timber truck on the road at the same time was chilling. It was agreed that a reply should be sent to MP. The letter should also ask for an update on progress with the promised gate through the plantation and on the removal of the escaped Sitka spruce from Aldoniag Glen the land west of Highlandman's before they grow too large for easy removal. A reply noting these issues will be sent to MP.

RB reported on the correspondence with Kirsty Sweeney regarding the cutting down of laurels near Ardenconnel House reported at the last meeting. Laurels are invasive but they are not on the Invasive Species list and with trunks in excess of 30cm are trees and therefore subject to the TPO. It was agreed that a reply should be sent from the Community Council.

ACTION RS AND JC

• It was noted that the Shandon Woodland Group is now functioning. A map has been produced, path clearing working parties have been in action and a botanical survey has been conducted.

8. ENVIRONMENTAL AND INFRASTRUCTURE GROUP

A report on the first meeting of the group was made available by DL.

There has been a problem with the recordings of speeds through Rhu and this is being addressed. DL has had a discussion with the chairman of Arnprior Community Council on his experiences with Stirling Council on the adoption of 20mph speed limits in the villages in Stirling. The role of the Project manager in the Roads Department and the funding was critical to the progress that has been made. A Project Manager(PM) has been finally been appointed in A&B and Hugh O'Neil (HO'N) has confirmed that the PM will contact us. It was reported in the local press that the first areas to be dealt with will be the Isles, because of potentially inclement weather in the winter period. We expect that the group will work with the MoD on active travel. It was reported that one of the two drainage problems associated with Blairvadach has been fixed. A future important issue is a further push for pavements on Pier Road.

9. UPDATE ON RHU AND SHANDON COMMUNITY TRUST

The confirmation of boundaries has delayed the finalisation of the purchase. It is hoped that a concert can be held in the woods on Wednesday 26th September. This first event for the community will be in conjunction with Cove Park with funding from ABCAN. Details later.

10. UPDATE ON PLACE PLAN

This is expected to be completed by 7th September.
