1. The Towns and BIDs Resilience and Recovery Fund,

Is intended to support localised response activities contributing to town centre and high street resilience and recovery. The fund is open to local authorities and constituted groups with suitable governance controls, including Town Centre Partnerships, Town Teams, Traders or Business Associations, Chambers of Commerce, Community or Development Trusts, Housing Associations, Council-led

2. Bòrd na Gàidhlig - COVID-19 Support Fund

Grants are available to provide groups in Scotland that deliver Gaelic projects with support during the coronavirus/COVID-19 pandemic. The funding is intended to help groups that deliver Gaelic projects to deal with the impact of the coronavirus/COVID-19 crisis, ensuring that groups can continue their work online, share resources and are well placed to recover from the crisis. Grants of up to £12,500 are available and can cover up to 80% of project costs. Match funding of at least 20% is usually required, unless discussed with Bord na Gaidhlig officers who may agree otherwise. 3. Third Sector Resilience Fund

The Third Sector Resilience Fund (TSRF) is a £20m emergency fund for charities, community groups, social enterprises and voluntary organisations working in Scotland. The fund supports organisations that already deliver services and products but find themselves in financial difficulties directly as a result of the coronavirus pandemic. The primary intention of the fund is to help third sector organisations to stabilise and manage cash flows over this difficult period. For Phase 2 of the Third Sector Resilience Fund, the guidance and criteria have been adapted to maximise the number of third sector organisations that benefit from it: Applicants must be at risk of or unable to cover essential costs within 12 weeks from the date of application. The maximum grant amount awarded will be £75,000. Funding requests must be for a three month period (previously four months) Eligible costs will be mostly limited to overheads and essential staff (administrative for example) who cannot be furloughed. Please visit the FAQs section for more detailed information. All grant applications requesting £50,000 or more will be considered for a loan, a grant or a blended approach (part grant, part loan)

4. Community Partnership 'Supporting Communities Fund' has opened for applications from community organisations and individuals in Loch Lomond and the Trossachs National Park in response to COVID-19. 5. Youth Scotland Action Fund

Youth Scotland's Action Fund has been established to help youth groups and youth workers meet the needs of young people in response to the Covid-19 Coronavirus. The Youth Scotland Action Fund has reopened. The purpose of this fund is to enable youth groups to purchase essential items that will enable them to continue working with young people throughout this period of social distancing and restrictions. 6. Independent Age Grants Fund

11. Self Employed Hardship Fund

Self Employed Hardship Fund can provide a one off grant of £2,000 for the newly self-employed who are facing hardship as a result of COVID-19 and who are not able to access other COVID-19 support. The purpose of this fund is to provide hardship relief to newly self-employed individuals who have not been able to access support through other schemes or have exhausted all other avenues for business support. Successful applicants will receive a one-off payment of £2,000. If you receive the grant you can continue to work or take on other employment including voluntary work. The fund is administered by Argyll and Bute Council in line with eligibility criteria set by the Scottish Government.

26. SUEZ Communities Trust Scottish Landfill Communities Fund - Primary Fund

Grants are available to non-profit making organisations in Scotland for projects under the categories of Land Reclamation (Object A), Community Recycling (Object B), Public Amenities (Object C), Biodiversity (Object D) and Historic Buildings (Object E). The Scottish Landfill Communities Fund is an initiative which allows landfill operators to release tax credits to environmental and community groups. The scheme broadly aims to benefit local communities in the vicinity of a landfill site. Grants of between £1 and £50,000 are available. Projects must have an overall cost of no more than £250,000. Before the Trust can release funding for a project, it needs to receive a payment called the Contributing Third Party (CTP) Payment. This will be 11.5% of the overall Primary funding grant.
