Street Lighting Stonehaven

Dear Councillor Black

I refer to your correspondence in which you asked about various street lighting issues in Stonehaven.

We spoke with local road colleagues about these lights and they offered the following list of updates in response.

Park Drive – Cable fault issue applies to all 3 jobs raised, no resources to repair currently.

634484 / 24/10/24 Job Raised / SL Additional Work Required
635370 / 08/11/2024 Job Raised / SL Additional Work Required
635440 / 11/11/2024 Job Raised / SL Additional Work Required

Mearns Drive – Job no 620764 Raised 28/03/2024, SL-Additional Work Required – No resources to repair currently.

Martin Avenue Hammerhead – 632489 / 30/09/2024 Job Raised / Works Order Committed. Looks to be Column 4 is the only one out in that area, will investigate further

Ramsay Road – Only one Job in location mentioned: 636190 27/11/24 Job Raised / SL – Additional Work Required – Replacement Head Required. Water Ingress from eye.

Evan Street - Column to be removed, no resources currently available to replace

Hunter Avenue/Drive - Unfortunately we do not have the budget this financial year to repair the street lights on Hunter Avenue/Drive. We have however included it in the prioritised list for capital street lighting improvements.

Market Square – Defects in this location have been repaired

Westfield Park – 632117 & 632116 / 26/09/2024 Job Raised / SL Additional Work Required – Cable Fault, no resources currently to repair this

Dunnottar Avenue / High Street (outside Police Station / Sheriff Court Building) – No outstanding jobs here reported on our system, will need reported on our online defect map to determine precise location

Dunnottar Avenue (junction beside Invercarron Vaccination Centre) - No outstanding jobs here reported on our system, will need reported on our online defect map to determine precise location

Mill of Forest Drive (beside Old Farmhouse & Scout Hut) – Location assuming Mill of Forest Road. Focus has been near The Scout Hut, we are unsure which property Old Farmhouse is. No outstanding job but clearer location/column unit number required, should be reported via online map.

Leisure Centre Car Park - Lighting Units R1, R2 & R3 are all affected J055. Cable Fault between R1 & R2 (damaged cable). No resources to repair currently.

The team would reiterate that reporting these faults and finding out more information on them should be done via our online defect reporting tool linked below which will allow precise locations to be given on defects to the team, and any already existing defects will be noted on the map for looking up information.
