The approved link road included for there being no vehicle access between the East Lodge development and the Netherley Road at the East Lodge corner.	
	Issues raised by public:  - Suitability of East Lodge Drive design for its likely use: road width and driveway arrangements - Impact on changes to masterplan, since link road was originally approved - Impact of the AWPR on the likely use of the link road - Accident risk in residential area - Increased rat-run risk of new proposal
