	weekend in London with a full programme of activity for 11 young carers accompanied by 3 staff. FB and

	Brian Duncan described some of the activity of Alcohol and Drugs Action including Assessment and
	Counseling services. He explained that addiction is often associated with underlying mental health
	problems. Aberdeenshire Integrated Joint Board have sponsored three community forums for North,
	Central and South Aberdeenshire. BD is co-chair of Aberdeenshire South forum. He described how they
	had established an Alcohol-Free Space at the Stonehaven Folk Festival and that this was being used as a

	model elsewhere in Scotland. He extended a welcome for anyone interested in attending next meeting	
	of the Forum at 12:30 on 28 th February in Mill of Banchory school. He expressed concern that services	
	for young people had been very badly eroded over the last 10 years.
