- Matters arising to consider any matters arising from the 13th May meeting RN advised nothing More to report regarding the grit bin. Regarding the Northern Powergrid grant application, no Decision seems to have been made yet and SM asked for the reference number and will make Enquiries about it. RN advised no progress on the carpark yet. RN asked SM for any more Information regarding the supply problems with Northern Powergrid and he has nothing to report Yet but will update when he has more details about a meeting to be arranged at Easington soon.
- To receive Ward Councillors report SM advised that he will be meeting members of Highways To do an inspection of the condition of the roads throughout Skeffling and has been advised that The Environment Agency hope to have the new pumping station completed by the end of the year So he will be pushing for repair work to be carried out on Humber Lane.

DH advised that members of the ERYC have put a sign up stating the bridge on the public right Of way at Foss Drain is unsafe and that repair work is to be carried out. This was discussed at Length as the problem was originally reported two years ago in January 2022 after a resident complained the route was unsafe to walk and nothing more has been done since then. RN advised that he has had complaints regarding this problem recently too and JS discussed another part near The village hall which is too overgrown to be able to access.

HW discussed the recent Coastal Changes meeting he attended and advised that there seems to be no plans to protect the coastline it is more to discuss options to manage the problem and will email round information for the Councillors to look at and details of more meetings planned.

DH discussed the problem with cars speeding on the main road through the village and this was Discussed at length with all Councillors having encountered problems with it. SM advised he will Send details of the help that can be provided by Humber Safer Roads and also discussed a new Scheme soon to be implemented by the Police and Crime Commissioner with potential for a static speed camera on trial which may be something the parish council can consider although a cost is involved.
