- 2/ Councillors to disclose interests in matters to be discussed - non
- 3/ To confirm Minutes of the meeting held on 1st April 2025 - proposed by **JS**, seconded by **HW** and agreed by all
- 4/ Matters arising - to consider any matters arising from the 1st April meeting - **RN** checked to see if **HW** had anything to report regarding the grit bin but this is still ongoing.
RN gave a reminder of the consultation meetings coming up soon for the Humber Hydrogen Pipeline and also Changing Coasts East Riding and Clerk advised that the Changing Coasts sessions need to be pre-booked. **RN** asked any Councillors who attend give a report at the next meeting.
RN advised that he has taken a video of the condition of Humber Lane.
 Regarding the Northern Powergrid Foundation, he has sent in an application for funding to cover a generator which will be kept at the Village Hall to enable residents to be able to use in case of power cuts in the village.
 No further progress regarding the car park.
- 5/ To receive Ward Councillors report - **SM** discussed attending a meeting with Graham Stuart, Ward Councillor Lyn Healing and Northern Powergrid to discuss the cause of power cuts in the Local area. Northern Powergrid advised they have no immediate plans to replace any major Infrastructure but will be carrying out repairs in the area.
 Northern Powergrid have been made aware that some residents are still using personal generators And want anyone who is using one to contact them so they can remedy the need for having to use one. All parties are looking to improve communications between Ward Councillors, Residents and Northern Powergrid.
SM advised that an extra £300,000 has been made available for the 'Do it for East Yorkshire' grant And will send more details to the Clerk for the parish council to consider an application.


Public Rights Period
