The Clerk was asked to formally confirm Mr Dempsey's instructions to remove the hard standing on the Village Green. Martin Byrne reported that the pothole repairs in Woodpiece Road had now failed.

Tappers have now visited the Hall and inspected the ceiling – a report is awaited.
- 128 Play Areas**
John Cooper and Martin Byrne signed the transfers relating to the new play areas. They will now be returned to CDC for completion.
- 129 Woodpiece Road Development**
CDC will revert to the Parish Council when plans are better developed.
- 130 Correspondence**
The Council is awaiting quotes from Speedicut and White Horse Contractors for work to the playing field..
- 131 Public Participation**
Concern was expressed over the number of play facilities in the Village. The Council explained that these had been required by CDC when approving the application for new housing. It was reported that the Royal Logistics Core is now moving into "C" site. This activity could increase lorry movements through the village substantially. Concern was also expressed over where the lorries would be parked. More police presence has been noted in the Parish.

It was agreed that the Fish and Chip van would be permitted to park in the Village Hall Car Park once a week for a trial period of 3 months. It was reported that the SSE switchgear will be being installed this week.
