<b>81</b>	<b>Declarations of Interest</b> The Chairman declared an interest in the Tally Ho planning application and took no part in the discussion on this item.
<b>82</b>	<b>Minutes</b> The Minutes of the meeting held on 5 <sup>th</sup> August 2014 were agreed as drawn.
<b>83</b>	<b>Matters Arising</b> It was confirmed that the garden of the property in Buchanan Road had been tidied. The Chairman has circulated a response from NHS England to his letter raising concerns about the reduction in opening hours of Ambrosden surgery. There is still flooding at the bus stop although this has been raised with OCC. Posters about the football teams have been placed in the Parish News. It was agreed that the Parish Council would consider CCTV after the roof to the Village Hall had been re furbished. OCC have now cut the verges in the village and the Chairman has cut back the brambles from the Plough along the footpath. It was agreed to consider tenders for work on the Village Green at the next parish Council meeting. Another recycling bin has been ordered and is awaited. The Chairman reported that he is awaiting a response from the Garrison to his recent letter. A blocked drain has been reported to OCC.
<b>84</b>	<b>Highway and Footpath matters</b> Both the Chairman and Neil Thompson have contacted potential contractors to carry out grass cutting work. There is a bush overhanging the footpath by Creek Ground Farm. After some research the Clerk was asked to report this to OCC. The Clerk was asked to ask Sanctuary to cut back the hedge between Harper Close and Greenfields.
<b>85</b>	<b>Police and Crime Update</b> Glass has been broken in the Noticeboard and the perpetrator has been given a caution. Neil Thompson agreed to advise the police of the cost of new glass, which will then be claimed form the parents. Versatile Building Maintenance will be asked to produce a split bill to cover this. Lee Savidge agreed to attend the next Nag meeting.
