Cromarty Rising... And Still Battling

It is almost four years since MSPs on Holyrood's Public Petitions Committee (PPC) began their consideration of the petition from Cromarty Rising. Earlier this month they decided they needed to continue their deliberations.

It was in March 2017 that Cromarty Rising lodged its petition – "Calling on the Scottish Parliament to urge the Scottish Government to ensure that environmental legislation in Scotland is sufficient to prevent ship-to-ship transfers of crude oil in environmentally sensitive locations, such as the Inner Moray Firth, and to enhance the accountability of trust port boards to their stakeholders."

The PPC's meeting of 12th November questioned Paul Wheelhouse MSP, Minister for Energy, Connectivity and the Islands as part of its review of the petition. Committee members then "agreed to consider the evidence heard alongside forthcoming written evidence from the Minister, and others with an interest in the petition, at a future meeting."

The event was available live on Holyrood TV and a recorded version is available <u>here</u>.

In previous correspondence with the PPC Mr Wheelhouse had been extremely evasive, and as a result, was finally called to attend in person by committee members. He attended together with Marine Scotland's Head of Ports and Head of Marine Conservation. Prior to the hearing, Cromarty Rising were invited to give an update to PPC members. A copy of that submission is on the Cromarty Live website and reading this may help understanding before watching the video, it can be accessed via this link.

For background, two documents are referred to during the engagement. One is the Scottish Ministers publication "Modern Trust Ports for Scotland: Guidance for Good Governance" (November 2012). It is important to note that this document has no force in law and, it absolves Ministers from involvement in port business. It also defines communities as "Stakeholders" of ports and sets a burden on communities who dispute port activities, such as ship-to-ship transfers or noise problems, that they must take the port to court as Ministers will not become involved. In the early part of proceedings, Mr Wheelhouse can be seen to read his answers directly from this guidance.

The second document is the "Harbours Scotland Act 2015". The key part of this Act of the Scottish Parliament is that ministers relinquished all control of Scottish trust ports in law, in exchange for several hundred million pounds of ports borrowing being removed from Scotland's national debt.

The video lasts for 1 hour and 3 minutes, those interested to see a Cabinet Secretary squirm and flounder may wish to make a pot of tea and have a wee seat. We lobbied PPC members extensively beforehand – very much within PPC rules - and were delighted to see our prompts arise as

questions to the Minister. John Finnie MSP, and former policeman, asks his own very incisive questions with some vigour.

The next steps will be for Paul Wheelhouse to reply to the PPC with the action points he took away. We will then have an opportunity to comment on his responses.

Work is continuing with many loose ends being completed before the start of the new season, including a refresh of our CCTV, three more pontoons to be installed (their anchoring brackets were installed last week) and guttering and drainage for the sheds. Hope you will agree that the harbour is looking very smart after its recent tidyup.

As announced on Facebook the other week, new funding applications to Historic Environment Scotland's Year of Coast and Waters Fund and the FCC Communities Foundation Fund have been successful enabling the Trust to progress work to progress some repairs to the stonework on the West pier, particularly in the area leading up to the bridge. Not only will this project improve access for all abilities but provide a work place training opportunity for trainees from the UHI Construction and Built Environment Course. We hope to start this by early March.

Lastly, the Trustees of The Friends of Cromarty Harbour charity thank everyone for their support in buying our latest jigsaw. Sales are now well over a hundred and twenty, more stock will arrive in January. Order through the harbour website. Wanda MacKay, Youth Development Officer said she felt lucky to have met Henry and described him as, "a kind and caring gentleman who has helped transform the lives of many young people here".

Development Trust

Just as the Newsletter was going to press, we received the welcome news that the Highland Council had finally granted the Cromarty Community Development Trust (CCDT) planning permission for a motorhome campsite at Whitedykes.

It arrived just in time. According to the regulations governing the Scottish Government's Rural Tourism Infrastructure Fund (RTIF), the trust had until Monday November 30th to get final consent from the planning authority, or it stood to lose the final £100,000 of its RTIF award.

The CCDT had understood all the necessary preparatory work had been done for planning permission back in March. The Highland Council's Transport Department, however, intervened seeking street lighting on the road along the length of the campsite.

Later the council's forestry officer lodged an official objection to the campsite plan. This was because of the number of trees that would have had to be removed. He proposed reducing the proposed fourteen parking bays.

The lighting issue was resolved to the council's satisfaction, but the trees proved more difficult. There was a protracted period of negotiation between the CCDT's architect Neil Grant and planning officials and the forestry officer. New plans were drawn up.

The plan finally approved is not what the CCDT had originally visualised for the site layout (view it here). There will only be 10 bays, and not the 14 on which the CCDT's calculations had been based. The official planning permission, however, should ensure that Cromarty does not lose out on £100,000 of investment.

It has proved a more complicated process for a voluntary body such as the CCDT to undertake, than originally imagined. The planning and the forestry officers were only doing their best to ensure our project was consistent with council policy. Indeed the CCDT directors are greatly indebted to the many Highland Council officials who have helped us get to this stage, not to mention Neil Grant.

Meanwhile discussions are continuing with Simpsons, the Beauly-based builders, with a view to them taking on the construction of the Whitedykes site. The development trust directors were delighted that the firm stepped in to save the slipway upgrading project, which was delivered on time and on budget.

Housing for Communities

A few weeks ago Community Land Scotland (CLS) published a report on the housing challenges faced by communities across Scotland. CLS Chair Ailsa Raeburn introduced the report entitled - "Home Delivery – Community Led Housing in rural Scotland"

She said "For too long people have been leaving villages and small towns across rural Scotland, because they could not find a house they could afford to live in, or were repeatedly evicted...In the fight against such depopulation, communities the length and breadth of rural Scotland have been coming together to build and manage their own affordable housing."

CLS is the representative organisation for community bodies which own land or other assets such as buildings from Eigg, Knoydart and Abriachan to the Bridgend Farmhouse in Edinburgh and the Kinning Park Complex in Glasgow. The Cromarty Community Development Trust is a member of CLS.

The report charts the success of the very many rural communities who have bought the land and raised the funds to build the required affordable housing over the last five years of the Scottish Government's Rural and Islands Housing Funds.

These funds were launched in 2016 and were worth up to £30 million. They helped groups such as community organisations, development trusts and private landowners to build new affordable housing or refurbish existing properties, and have already supported projects that will deliver around 200 homes.

The funds (now treated as a single fund) were due to be reviewed early next year after which a decision would be taken on whether they were to continue. The CLS report was designed to persuade ministers to continue the funding beyond this financial year. It seemed to work. Shortly after its publication Housing Minister Kevin Stewart announced the funds would continue to operate. He said:

"It is important for the Scottish Government to help our valuable rural and island communities to provide sustainable affordable housing in their local areas. The Rural and Islands Housing Funds were set up to address some of the issues these areas have faced and have been described as 'game changers' by the Scottish Land Commission, providing a vital boost to affordable housing in remote rural Scotland and on our islands.

"One or two homes in a small community can be as important as a large-scale development in a city. I have seen at first-hand how these funds supported a development of 12 homes in the village of Drumnadrochit that has allowed older residents to live independently, with support from a nearby day centre — an inspiring project created by the community themselves."

On Skye the Staffin Community Trust faced a big challenge. The island with a population of 10,000 has particular pressure on its housing stock. Research for the Scottish Government last year found that almost 20% of all dwellings on Skye were available for holidays through Airbnb. Hugh Ross of the Staffin Trust said:

"We refused to sleepwalk into becoming a retirement village dominated by holiday accommodation. Our project (seven houses) would have not happened without the Rural and Islands Housing Fund. It is a project that is vital to Staffin as we haven't had affordable houses here for 21 years. This development will see seven families secure homes, bolster our schools roll, provide a modern heath centre and new business opportunities in Skye and Lochalsh's most economically fragile community. The sound of children playing in the gardens will be a very welcome noise – that of a community with a bright future."

As we all know Cromarty has also been facing the problems created by the lack of affordable housing for many years. The primary school toll has already been halved in less than a generation. The Cromarty and District Community Council is leading on the issue of housing in partnership with the development trust. Albyn Housing's plans for a housing development in the field beside the Victoria park, have again been postponed.

The CLS report (<u>link here</u>) is worth reading to see what can be done. Readers of the Newsletter may find its style familiar, as the report's author, David Ross, is a member of the Newsletter's editorial board and a CCDT director.

Anyone for a drop of Cromarty Gin?

CCDT directors have had a very positive follow up meeting with the owners of Sutor Gin to discuss the development of a Cromarty Gin brand. Plans are coming together and we are hopeful that there could be a community engagement event early next year. We hope this might involve some samples!

More information will be available to members at the CCDT AGM on the 16th of December at 8pm. Members will receive an email with a link to the online meeting over the next few days.
