### 3.5.1 Lochcarron

Hamish and Phil ran a field test from Lochcarron to Creag Mhaol which proved the line of sight. However the signal could have been stronger and so it was decided to upgrade the dishes to increase the power. See 8.2.1

We will configure an upgraded dish to allow us to retest the link to Lochcarron.

## 5 Finance Director's Report

### 5.1 Monthly Update

Hamish has very nearly caught up with the accounts and it was decided we would have a separate meeting between Hamish, Mary and Phil to finalise the details.

We are now ready to submit our next claim to CBS for the second tranche of equipment, this will be approximately £6,000 and we will therefore have to raise about £700 in new loans to cover our contribution of 11%.

In addition to the capital costs we will have advance quarterly ADSL & telephone line rental costs of £800 to pay and we will therefore need to raise loans to cover these until subscriptions are received.

Phil is to provide Hamish with the MAC codes to indentify equipment and confirm the warranty periods.

The Opening / Closing balance figures are now out of date; we will produce a corrected figure next month.
