3 Chairman's report

3.1 Bandwidth

Bandwidth has now mostly recovered in the evenings; we will continue to monitor speeds. Action: Phil

3.2 CBS

On the 22nd October we met with Zoe Laird the new head of CBS and Jeremy Firth, Tim Winterburn and Calum Stiven. Tim & Calum visited Duncan Ferguson to interview him and see how higher broadband speeds had impacted on his life. We had a wide ranging discussion with Zoe & Jeremy and covering areas where CBS might be able to be of more help to Community Groups.

During the meeting Zoe said she would ask about the BT / HIE developments in the area on our behalf. Zoe did follow this up and we have received an update from Nick Scroggie at HIE.

Nick tells us that BT has installed the first fibre cabinet in Lochcarron and this is about to go live, two more will follow in the next few months. The first fibre cabinet is expected to be installed in Plockton early next year and will be located near the BT exchange.

When the fibre cabinets are in use we can expect speeds to increase from our current 8 Mbps (upload + download) to around 24 Mbps, there will be no extra charge for this increase. However if we were to switch to a FTTC (Fibre To The Cabinet) service (which will be more expensive) speeds would rise again to around 48 Mbps or more. As the final link from the new cabinets to our equipment is still through the existing copper wires the usual caveats apply about the length and condition of the copper wires. So we won't know what speeds are available until we can get a connection from the new cabinet and test it. But it will be faster that our existing links.

We will check with Zen if they have a date for the Lochcarron upgrade. Action: Phil

Nick also reported that no details are available for our exchange (Strome Ferry) and these plans are not likely to be known before the end of this year.

After we met with Zoe we were asked by Calum to help with the next WHAN meeting which will discuss the West Coast Backbone. Mary has agreed to chair the next meeting and in the past few weeks considerable time has been spent preparing for this meeting including 6 hours of meetings with Calum. The meeting is scheduled for Thursday 19th November, Mary, Hamish and Phil will attend.

7 Customer Relations

7.1 Production Environment

7.1.1 Problems and complaints

No complaints this month. One cable had to be reinstalled due to K9 intervention. Phil issued a draft copy of the Problem reporting procedure for directors' comments and will incorporate all the suggestions received. This will be distributed when the new subscribers go live; i.e. when the new Lochcarron line is delivered.

The daily stats program has been amended and will now retry six times to connect to Google Mail; since this change was made there have been no problems.

The daily stats programs have been ported to a new machine that will automatically recover if there is a power failure. So far this seems to be working well but more changes are required to the programs to cater for the different environment.

7.1.2 Usage quotas

The daily average usage in September was 7.7 GB; total usage was 231 GB (238 GB for a 31 day month) a slight decrease on August's 252 GB. Three subscribers exceeded their quota in September, Phil has issued invoices.

The daily average usage in October was 9.2 GB; total usage was 284 GB a big (20%) increase on September's 231 GB. Ten subscribers exceeded 90% of their quota; a further six exceeded 60%.

7.1.3 Possible virus infection

Some spurious addresses have been flagged by the management software this month; this may be due to virus infections or subscribers attempting to replace CMNet equipment. We will investigate further when time permits.

7.1.4 Installation of domestic equipment

Six installations were completed since the last meeting; a further two installations are pending waiting on subscriber's preparatory work. Installations were being scheduled to coincide with the arrival of the new Lochcarron ADSL line which was subsequently delayed. Subscribers will be connected as soon as the new line becomes available.

8.3.1 Lochcarron

Phil & Joe finished the work required for the electrician and the he visited and connected the power. Openreach visited but did not connect the telephone line as they should have sent their surveyor first. We are waiting for a new installation date from Zen / Openreach.

There is a small configuration change required to the dish and additional bracing will be installed for the mount on our next visit. Action: Joe, Phil

8.3.2 The Glen

Neil has completed work on the trench and the new cable has been installed and connected; the trench has been backfilled. SSE has connected the power and the meter has been ordered and installed. We have asked our electrician to connect our consumer unit. We will register the new meter with our electricity supplier. **Action: Mary** Activating the installation is now dependant on the new line being installed in Lochcarron.

8.3.3 Ardaneaskan

We still do not have an agreed location for the Ardaneaskan relays but we have connected one resident via a temporary link direct to Creag Mhaol to test the range of the new dishes (NanoBeam CPE). There is a possible solution to the relay problem but no work has been done on this due to other priorities. **Action: Phil**

We now have the lease from the Forestry and have applied for the power connection from SSE. So far SSE has not given us a connection date but it is likely to some weeks before the power is available.
