8.2.1 Creag Mhaol

We all went up to the current relays to see if there was scope to provide access points for North Strome; another trip is required before we draw any conclusions. **Action: All**

8.3 Backbone development

We will pursue Creag Mhaol as a possible location for the North Strome access points. Action: All

8.3.1 Lochcarron

Andrew dug the trench and laid the new BT cable and exposed the old cable ready for Openreach to splice and complete the installation on the 5th February. Phil arrived at the appointed hour and waited, and waited, and waited and waited no Openreach. We subsequently discovered that Openreach had cancelled the installation the previous day because more wok was required at the exchange. Openreach did not inform Zen and so Zen could not inform us.

We were then told that the work in the exchange would be completed by the 12th Feb and we would then be given a new installation date.

On Friday 12th Feb we were told that Openreach had now decided that more cabling is required before our line can be installed and the new target date is **mid May**. We ordered the line in September so a May delivery date will be a delay of **eight months**.

A further three month delay is unacceptable but our chances of getting Openreach to move are zero. Our only other option is to try to get an earlier delivery date for a line in Plockton. See 8.6.2

We have agreed with Andrew that we will make a box to fit over the hole where the cables are exposed so they can be buried out of sight until Openreach return in May.

8.3.2 The Glen

We are still waiting for the installation of additional capacity and our electrician to connect our consumer unit. **Action:**Phil

8.3.3 Ardaneaskan

The new kit is working well for a domestic installation but may not be suitable for multiple users; we will run more tests before reaching any conclusions, no change. We have started to look at alternative locations for the access point relay.

Neil & Joe have dug the trench and laid the cable. Phil will check the cable run through the scaffold and lay the warning tape. We can then contact SSE to connect the power. Once SSE has done their work we can apply for a meter and once the meter is installed ask our electrician to connect up our consumer unit. **Action: Phil**

Due to the interminable delays with the Lochcarron line we have decided to order another line for Plockton. This is not ideal as we want to be able to balance the load across two exchanges, which we cannot do until Openreach deliver in

Lochcarron. We are also tied into two year contracts with the existing Plockton lines which do not expire until May 2017 so we may incur additional costs.

In their usual customer friendly manner Openreach will not give any indication of the delivery date for the new line until we place an order so there is no guarantee this line will be installed any sooner than Lochcarron.

However it was unanimously decided that sitting on our hands for three months is not acceptable so we will proceed with the Plockton order ASAP.
