# Minutes of the Meeting held on the 15<sup>th</sup> June 2016 @ 7:30 p.m. Fernaig House

## 1 Present and Apologies

## 3 Chairman's report

#### 3.1 Bandwidth

Bandwidth is now back to normal after April's problems and rarely drops below 4 Mbps - see 7 for more details. Combined usage through the backbone shows bandwidth is reaching peaks over 14 Mbps out of a maximum of 21 Mbps for downloads and 1.2 Mbps out of a maximum of 1.8 for uploads. Each of the three individual lines will regularly reach their maximum utilisation at peak times of the day but fortunately not at the same time. We reach the peaks on upload capacity more often than download.

Zen report that the new line in Lochcarron has now been installed but we have not yet had time to confirm it is working as expected; this will require a trip to Lochcarron on a dry day.

Joe has researched Openreach progress in Plockton and discovered that several fibre cabinets have now been installed. Phil checked with Managed Comms and Mary checked with Zen and both ISPs confirm that our lines at the school can be upgraded to use the new cabinet near the exchange.

There is a small installation fee and a small monthly rental increase but the benefits are well worth the extra charges:Download speed should be between 34 Mbps and 78 Mbps; the actual speed depends on the length and condition of
the copper wires and has been estimated at 60 Mbps, i.e. about 8 times the speed of the current lines.

Upload speed show the biggest gain as it will be between 12 and 19 Mbps and has been estimated at 17 Mbps or 25 times the speed of the current lines.

The increase in monthly rental is under 10% and is offset by the fact that the fibre connection will be able to support much higher usage, this should mean we can reduce the number of lines we use once our current contracts expire.

However past experience has shown that an upgrade could cause an outage on the line whilst we wait for any problems to be resolved. It was therefore decided that we would make sure that the new line in Lochcarron was installed and fully tested before we risk problems upgrading one of the Plockton lines.

The upgrade to fibre at the Plockton exchange gives us the potential to start to increase speeds above 5 Mbps and at the same time reduce our tariff.

Zen confirms that the Lochcarron exchange has not yet been upgraded to fibre.

The meeting in Lochcarron for Strathcarron was well attended by residents from Ardaneaskan to Achintee. Strathcarron has around 20 potential subscribers. CBS stated that the only way for them to get funding is to join CMNet. It is early days for them and the next step will be for them to survey their local households to determine the support.

One subscriber has reported that their internet connection fails for brief periods. We have asked then to note the exact time and inform us as soon as possible so we can check the logs. There were no reports of any other defects this period.

We have received queries about quota usage and subscribers should note that the only way to be certain they do not switch to CMNet through a Wi-Fi connection is to turn off the mains power to their AirRouter or AirGateway.

Statistics show that the download speeds have now returned to normal with the slowest speed recorded being 4.29 Mbps, upload speeds have improved slightly.

Joe is still having problems updating firmware, this is not a high priority to fix and will be addressed in due course.
