7 Customer Relations

7.1 Production Environment

Drop outs in Braeintra - no incidents reported this month so we will close this problem. Closed

Drop outs in The Glen - we have replaced the subscriber's router. We will close this report if no other incidents are reported. **Action: Subscriber**

One subscriber reported poor performance in Braeintra - this is down to obstructions in the line of sight of the subscriber's antenna. **Action: Subscriber**

Drop outs in Craig - we are still receiving reports of drop outs some were down to false RADAR others down to the subscriber's loose cables. **Action: Phil**

Unable to access a website - One subscriber has reported they cannot access one specific website since we made the switch from Zen to Plusnet. We will replace the Achmore Hall router and then rerun the tests. This change is pending the changes to the dish at Plockton so we can make the router change without interrupting the service. **Action: Phil**

There are still a few Ubiquiti units to upgrade to the new version of firmware this will be scheduled in due course.

7.6 Revised Terms and Conditions

A revised set of terms and conditions for new installations was circulated and agreed. The new terms and condition will apply to all new installations, other than those who have agreed to be test sites.

7.7 Whole House Wi-Fi

It was agreed we will provide two options:-

7.7.1 Option 1

An Ethernet wired solution. We will provide the Ethernet cable but the subscriber will have to install the cable run(s). As part of the deal we will terminate the cable with RJ45 plugs and configure the additional units. There are two options for additional equipment a basic router (2.4 GHz only) or an enhanced router (2.4 GHz & 5 GHz).

The charge will be £1 per month for each additional basic router and £2 per month for each enhanced router.

7.7.2 Option 2

A mains LAN extender solution. This requires a base unit to be located near to the existing CMNet router and additional unit(s) to extend Wi-Fi coverage. Because of the limited performance of the LAN extenders we propose to only provide a basic router (2.4 GHz only).

The charge will be £1.50 per month for the base unit plus £2 per month for each additional basic router and secondary extender.

Both options are for a minimum term of 2 years and are only available to CMNet subscribers. Both options include a site survey and in the case of the mains LAN extenders an onsite trial.

We will maintain all the equipment and will provide a performance guarantee for the Ethernet solution, we cannot provide a performance guarantee for the mains LAN extenders as their performance depends on factors outside our control. But before making a commitment the subscriber will have the benefit of the results of the onsite trial.

8 General topics

We have received a draft lease agreement from our solicitors; we have yet to go through this in detail. We will need to reconfirm all the GPS coordinates of the relays before we can proceed; priority will be given to completing the set up of the relays on Creag Mhaol.
