Members are reminded that under the Code of Conduct they are not to participate in the whole of an agenda item in which they have an Interest. In the interests of transparency, Members may also wish to declare any other interests they have in relation to an agenda item, in support of the seven Nolan Principles, namely Selflessness, Integrity, Objectivity, Accountability, Openness, Honesty and Leadership.

day passed by (in one direction), the 85th percentile speed was 32.1 mph (in a 30 mph limit area) with the maximum speed being 55 mph, and **to consider** any action necessary. Not surprisingly these figures are all lower than those obtained on Rocklands Road during January, but 26% were exceeding the speed limit.
