Minutes of the Annual Meeting of Stow Bedon & Breckles Parish Council on Monday, 12 May 2014 at 8.00 p.m. in Caston Village Hall.

## 11 Planning.

- 11.1 **Breckles Heath applications appeals**: As requested, the Clerk had included a copy of the statement from Norfolk County Council's Highways submitted to the Planning Inspectorate for information. He reported that final comments were due by 1 April, but the Appeal was still "on progress".
- 11.2 **3PL/2014/0412/O: Stone Leigh Cottage, Mere Road, Stow Bedon**. Application for Erection of 4 bed dwelling & detached garage. It was **resolved** that the Council had no objection on condition that the position of the new house was amended so as to be correctly aligned with the existing properties on either side, rather than projecting forwards as it does on the plans. This amendment should be made to ensure conformity with Policy DC16, "Particular regard should be given to reinforcing locally distinctive patters of development, landscape and culture and complimenting existing buildings."
- Casual Vacancies. Members had approached potential members but without success. Another name was suggested, and will be pursued. The Clerk was asked to keep including the item on future agendas.
- Road names. The Clerk reported that both Norfolk County Council and Breckland Council were agreed that the correct name of the road passing through Lower Stow Bedon from the junction with the B1111 and the junction with the B1077 (which road is known by Breckland Council as Caston Road and by Norfolk County Council as Carbrooke Road) is actually Rockland Road. It was agreed to accept their decision, but to ask Breckland Council to advise Google, as on their online maps they call Rockland Road "Bray's lane" from the junction with Mere Road northwards to the B1077 junction.
- **Pingo Trail**. Councillor Jessett said she had learned that there had recently been a theft from a car which was parked in the Pingo Trail car park. The Clerk agreed to ask Ian Monson to chase this.
- **Training.** The action taken by the Chairman and Clerk in signing an Application Form for the Clerks' Training Bursary Scheme to obtain 50% of the £25.00 cost of the Clerk attending the Understanding Standing Orders Training course was **confirmed**.
- **Receipts & payments account**. The Receipts & Payments Account 2013/2014 was **approved** by the Council and **signed** by the Chairman.
