Minutes of a Meeting of Stow Bedon & Breckles Parish Council on Monday, 10 June 2019 at 7.30 p.m. in Caston Village Hall.

Before the start of meeting, Councillors Morfoot, Pilkington and White signed their Declaration of Acceptance of Office forms.

- 1 Chairman's Declaration of Acceptance of Office. Councillor White signed the declaration, which was received.
- **Apologies for absence**. It was **resolved** to accept the reason for absence given by Councillor Howe.
- **Declarations of interest**. None.

- 5 Public participation session.

### 9 Planning.

- 9.1 **3PL/2019/0272/F: Flybarn Farm, Rockland Road, Stow Bedon**. Application for Erection of new self build, zero carbon dwelling and detached garage. It was **resolved** that the Council objected because of concerns that the entire site of 1.8 hectares of agricultural land has been included in the site for just one dwelling, which is clearly excessive for a garden. The Council also has found that part of this site is designated in the Stow Bedon Enclosure award as being allotted to the Surveyor of the Highways, and therefore they may well be a question over ownership which needs to be investigated by Breckland. The Council did, though, welcome that the development would remove redundant farm buildings, and had no objection to the proposed dwelling *per se*.
- 9.2 3PL/2017/0878/F: Wayland Farms Limited, Cherry Tree Farm, Sandy Lane, Stow Bedon. A report from District Councillor Phil Cowen that Breckland Planning Committee had given permission to this application was **noted**. Formal confirmation is awaited.
- **Community Speedwatch**. The Council regretted that PC Gilluley had not be able to attend this meeting, and agreed to carry this item forward to the next meeting. The Clerk was requested to ask if the Speedwatch Co-ordinator for Caston would be able to come to the next meeting to give the benefit of his experience.
- **Authorised signatories**. It was **agreed** not to make any changes to the signatories, which remain any two out of Councillors Childs, Jessett and Pilkington.
