Minutes of a Meeting of Stow Bedon & Breckles Parish Council on Monday, 13 December 2021 at 7.30 p.m. in Caston Village Hall.

- **1 Apologies for absence**. It was resolved to accept the reasons for absence given by Cllr. Morfoot and Cllr. Pilkington.
- 2 Declarations of interest. None.
- 3 Dispensations. None.
- 4 Public participation session.
 - 4.1 A member of the public outlined his objections to the planning application which was the subject of agenda item 8.2, and Cllr. Reed also quoted from a number of messages she had received from other residents on the same subject. District Cllr. Phil Cowen said that he had spoken with Simon Wood about the application, and been told that, despite the advertised deadlines for responses, it would not be determined quickly, and therefore comments received soon after Christmas would be considered acceptable. He, and the whole Council, urged residents to submit their views (whether in favour or objecting) to Breckland Council.
 - 4.2 Cllr. Cowen provided an update on Charry Tree Farm, saying that the current applications already lodged were not going to be determined any time soon, partly because a resident had lodged a complaint with the Environment Agency. Simon Wood had also met with the Agency, and Breckland Officers had conducted a site visit, saying that there were a lot of matters which needed rectifying, A meeting with the Agency is planned in the new year.
- **Minutes**. The minutes of the meeting held on Monday, 15 September 2021 were **confirmed**, and **signed** by the Chairman.
- 6 Matters arising.
 - 6.1 [12, Minutes of 18 October 2021] **Pingo Trail layby/Car Park**. Cllr. White said that he had continues to chase the NCC officer who was dealing with this, but had heard nothing in response to his suggestion that rather than wait for years for the perfect solution, the Council should arrange for a quick fix at no cost to NCC.
 - [10, Minutes of 15 March 2021] **Covid**. The Prime Minister has now announced some reversion to Covid restriction measures, but the Government has still not done anything about making virtual meetings possible. The Clerk was asked to write to Liz Truss, MP, and also to Kemi Badenoch, Minister for Levelling Up Communities, urging them to implement emergency measures again to allow Councils to meet virtually for the safety of Councillors, staff and public.

the Council to agree its comments at the next meeting, but also submit a holding comment refuting the false claim that the Parish Council had "but refused any presentation of this proposal", when the truth was that it had not been approached. It was also **agreed** that Cllr. Cowen should be asked to request that the application be called in for determination by the Breckland Planning Committee should the officers be minded to grant permission.

- **9 Volunteer Emergency Telephone System (V.E.T.S.)**. At the recent Defibrillator familiarisation session mention was made of this system, under which trained volunteers can be contacted to fetch and deploy the defibrillator in emergencies. The Clerk was asked to put a piece into *The Waylander* to see if enough volunteers would come forward to take this on.
