2. Structure, governance and management.

- 2.1. Governing document: Conveyance dated 20 September 1952 as amended by Scheme sealed 14 February 1985.
- 2.2. Appointment of Trustees: The Trustee is Stow Bedon & Breckles Parish Council, consisting of up to seven members, elected every four years.

3. Financial Review.

- 3.1. The Charity's reserves are invested and the income used to further the charity objectives.
- 3.2. Investments:
 - 3.2.1. The Charity's investment of £16,917.84 7¾% Treasury Stock 2012-2015 matured and was repaid on 26 January 2012. This is being held on an Active Saver Account with Barclays Bank while a decision about longer term investment is made.
 - 3.2.2. F&C Investments:
 - 3.2.2.1. 2,380.83 Stewardship Income SC1 Income shares, and
 - 3.2.2.2. 831.18 Stewardship Income SC1 Accumulation shares.
 - 3.2.2.3. The value of these shares as at 29 February 2012 was £4,641.84.

7. Achievements and performance:

- 7.1. An Active Saver Account was been opened with Barclays Bank Plc to hold the maturing proceeds from the Treasury Stock while investigations took place into have to invest it for the longer term.
- 7.2. The Trustee had several meetings with Ewan Graham of Ardent Financial Management Limited, a Senior Partner Practice of St James's Place Wealth Management, and the decision has been taken to place the bulk of the Charity's funds with them for long term investment.
- 7.3. The Charity has continued to support various organisations although the Trustee is very aware that it will be difficult to continue to do so at the same level in the future, unless that market improves considerably.
