### The Black Horse Public House

Email received from Mr Paul Kuznecovs, March 11th 2025, re: The Black Horse Public House.

"Dear Cold Ashby Residents, The Black Horse has not been abandoned – it has been fortified/conserved as a response to the security concerns experienced by Kuznecovs Family in Cold Ashby. As the renovation works have been completed and Kuznecovs Family decision not to re-open as a public house, due to it being unviable – the premises are currently vacant until either CACPG takes over it or planning permissions are granted in support of the current owner visions.
