GENERAL NOTICE OF REGISTRABLE INTERESTS

I, ALEXANDER JOHN TAYLOR (name in full) a Member of the

"Disclosable Pecuniary Interests" are required to include the interests of the Member and, also, their spouse or civil partner or a person with whom they are living as husband and wife or a person with whom they are living as if they were civil partners, if the Member is aware of the interest.

<p>Any Corporate Tenancy where –</p> <p>(a) the landlord is the Council; and</p> <p>(b) the tenant is a body in which one of us has a beneficial interest.</p>		
<p>Any Securities (stocks, shares, bonds etc.) of a body in which there is any beneficial interest where</p> <p>(a) that body to my knowledge has a place of business or land in the area of the Council; and</p> <p>(b) either –</p> <p>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which one of us has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>		

2) "Other Disclosable Interests"

"Other Disclosable Interests" are required to include the interests of the Member's family or a person with whom they have a close association, if the Member is aware that that other person has the interest.

<p>Any interest in business of the Council where –</p> <p>(a) a decision in relation to that business might reasonably be regarded as affecting the well-being or financial standing of myself or my family, or a person with whom I have a close association, to a greater extent than it would affect the majority of the Council Tax payers, ratepayers or inhabitants of the ward for which I have been elected, or</p> <p>(b) it relates to, or is likely to affect, any of the interests listed in the appended Schedule to the Code of Conduct for Members in respect of a member of my family or a person with whom I have a close association;</p> <p>and a member of the public with knowledge of the relevant facts would reasonably regard the interest as so significant that it is likely to prejudice judgement of the public interest.</p>			

3) "Non-disclosable Interests"

(a) Any body of which I am a member or in a position of general control or management and to which I am appointed or nominated by the Council.	
(b) Any body – (a) exercising functions of a public nature; (b) directed to charitable purposes; or (c) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union), of which I am a member or in a position of general control or management.	I am a member of the Cold Ashby Playing Fields Association Committee, and of the Cold Ashby Sports and Social Clubs committee. (CAPFA and CASSC) CAPFA has Charitable Status
(c) Any person from whom I have received a gift or hospitality with an estimated value of at least £25.	

Sensitive Information

Where it is considered that disclosure of details of an interest could lead to violence or intimidation, and the Monitoring Officer agrees, any published version of the Register of Members' Interests will exclude details of the interest but may state that there is an interest, the details of which are withheld.

Notification of Interests

I recognise that to omit information, which ought to be given within prescribed time limits in this notice or to provide information, which is materially false or misleading, is a breach of the Local Code of Conduct and, in respect of Disclosable Pecuniary Interests, can be a criminal offence.

I also recognise that failing to give further notices in writing to the Monitoring Officer within 28 days of becoming aware of any change in order to bring up to date information given in this notice, or in order to declare an interest, which has to be declared, and which are acquired after the date of this notice is also a breach of the Local Code of Conduct.
